Course Description

This course provides training in critical reading and academic writing. It focuses on the writing process and rhetorical concepts while requiring students to read and write a variety of texts. Students will be required to prepare a synthesis paper of moderate length demonstrating critical reading and academic writing skills, including selection, evaluation, analysis, integration, and documentation of sources.

Textbook & Instructional Materials

- The readings for the class are found on D2L through Macmillan. Most of the chapter readings will be from "In Conversations" with Mike Palmquist; Barbara Wallraff. Additional readings can be found in the modules.
- This course fulfills a core requirement for **Communication**. As such, the course will assess the following learning objectives:
 - Critical Thinking, Communication, & Personal Responsibility - To assess these skills, the Synthesis rubric will be applied to the Synthesis Essay.
 - Teamwork - To assess the student's teamwork, the Peer Review Teamwork rubric will be used to assess each student's preparation for and participation in a peer review workshop.

Course Goals:

- Apply key rhetorical concepts through analyzing and composing a variety of texts
- Engage in a writing process that includes invention, drafting, collaboration,

and revision

- Use reading and composing for inquiry, learning, thinking, and communicating in various rhetorical contexts
- Use strategies – such as interpretation, synthesis, response, critique, and design to compose texts that integrate the writer's ideas with those from appropriate sources
- Use sources ethically and in contextually appropriate ways and follow a designated style guide
- Demonstrate proficient use of linguistic structures, including grammar and mechanics, through practice in composing and revising

Midterm Grades: In order to help students keep track of their progress toward course objectives, a Midterm Progress Report through each student's Navigate account will be provided by the instructor. Midterm grades will not be reported on the students' transcripts; nor will they be calculated in the cumulative GPA. Students earning below a C at the midway point should make an appointment with the instructor and consider visiting the Tutoring & Academic Support Programs Center (TASP).

Submission Format and Policy: All written assignments are to be typed and formatted – and outside sources documented - according to MLA or APA style. All papers will be uploaded into the D2L Dropbox folder.

By enrolling in this class, the student expressly grants MSU a "limited right" in all intellectual property created by the student for the purpose of this course. The "limited right" shall include but shall not be limited to the right to reproduce the student's work product in order to verify originality and authenticity, and for educational purposes. Please note that the D2L Dropbox folder will automatically run the paper through Turnitin.com. Turnitin provides both an Originality Report and an AI Report.

Note: You may not submit a paper for a grade in this class that already has been (or will be) submitted for a grade in another course, unless you obtain the explicit written permission of me and the other instructor involved in advance.

Overview of the Course

Here are the major assignments in this class:

- Reading Responses/Discussion Posts
- Rhetorical Analysis
- Annotated Bibliography
- Synthesis Essay (Research Essay)

I will give you a handout for each formal assignment which will detail the assignment requirements and will include a rubric explaining how I'll grade the assignment.

Reading Response and Respond to Fellow Students: 20 points each

The readings will often be accompanied with a Discussion Post. These are usually worth 15 points each. Informal, exploratory writing is a good way to improve your writing skills. You will need to write a response to the readings assigned for homework. Unless otherwise stated, these homework responses should be at least **2 paragraphs** in length. Please **DO NOT SUMMARIZE**, instead provide your response to the readings. Please use "I-statements" and focus on your individual response to the readings.

The responses can be a response to what you have read or you can include questions that you still have about the readings. You can include what you liked or what you learned from the readings. You can include how the information applies to what you are doing for this class or how the readings apply to other classes.

You can receive either full credit or no credit on the responses and the due dates are listed on the Weekly Schedule. You will also be required (unless otherwise stated) to **respond to at least 1 other post** from a fellow student. Those posts must be at least **3 sentences long**.

While missed Discussion Posts cannot be made up, you are allowed to miss 2 posts without penalty to your grade. I will deduct these points at the end of the semester.

- Please post directly into the assignment and do not attach a file.

Attendance and Participation

Assignments are due on Wednesdays and Sundays.

- Please let me know if you will be missing an assignment or if you need an extension on an assignment. Please inform me prior to these absences so that arrangements, if warranted, can be made.

- I will mark all missing work as a “0” and will go back and change your score after you have submitted your assignments
- I will only accept late work for a week after the deadline. Discussions are not accepted late. This class builds on previous days and so anything older than a week is out of context and no longer as helpful to the class content.
- Discussions are not accepted late, but I will drop your **two lowest scores** at the end of the semester.

Weather

If the university closes due to weather, all deadlines will be changed to accommodate the closure. If the university is not closed for weather, then the deadlines will not be changed. On occasion, there may be times that the course will shift online due to weather, but this will only happen after an email will be sent to let students know of the change. Please email if you have weather related driving concerns.

Technology

Students in this course will need a working and reliable computer and internet access that will allow the use of D2L course site tools, Google Drive, and any online resources provided. No special software is required but students will need access to MS Office products. I encourage you to bring a laptop to class.

Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. Writing tutors will not edit your papers for you, but they do provide support and feedback at all stages of writing, from brainstorming to drafting, revising to proofreading.

When using the content or ideas of others, both published and unpublished sources, students must use accepted documentation conventions (e.g., APA or MLA). - All work submitted to D2L will be scanned by the Turnitin® program, which flags text that has been quoted from other sources and/or generated by AI tools such as ChatGPT
- AI/ChatGPT: In this course, you are welcome and encouraged to use artificial intelligence platforms such as ChatGPT, but mainly for pre-writing tasks and brainstorming. That said, you should not be using AI to produce your assignments or otherwise perform the "brain-work" that you are expected to be able to do (or learn to do) on your own. Doing so will result in a grade of zero for the assignment. If this happens twice, you will receive a grade of "F" for the course.
 - Please be aware that many professors do not allow AI use in their classes. Please check with your professors.
- When using the ideas of other published and unpublished sources, students must use accepted documentation conventions (i.e., MLA or APA). If you submit an assignment in which quoted content is not placed in "quotation marks" and/or you have not cited the correct source, you will receive a grade of zero for that assignment. If this occurs twice in the course, you will receive a grade of "F" for the course. There are no exceptions to this policy.
