Course Description

This class presents a general overview of Latin American literature, from the period known as Realismo to the end of the Twenthieth . The most important literary, cultural, and historical movements of this period will be studied. Through the readings, which will be discussed in class, the student will expand his/her vocabulary and improve his/her understanding of literary texts. The student will also be able to identify the most important Latin American writers and their works, in the genres of narrative, poetry, and essay; in addition to acquiring knowledge and understanding of the development of Latin American literature.

Participación

Participation: students must express their opinions and questions about the readings orally in class. For participation only comments that reflect a critical reading and reflection will be taken into account.

Exámenes

During the semester there will be 3 written exams about the works, the authors, and the literary period to which they belong. There will be a multiple choice section and an essay section.

Paragraphs

Every other day you will be asked to write a paragraph over the assigned readings, sometimes it will be an opinion about the reading, and sometimes it will be only a summary of it.

Final exam

The final exam will have two sections: one of multiple choice that will cover the authors and works studied, as well as the characteristics of the period in which the works were written; and another one, an essay in which different works will be compared.

Extra Credit

Part of the university student's life is to expand your intellectual horizons. Students will receive extra credit for attending some university functions, previously indicated by the teacher.

Make up work

In Spanish, the concept of 'make up work' does not exist. If you miss a quiz or paragraph you will receive an 'F'. If you fail to take an exam, you must present a medical proof or some other verifiable proof that you have missed the exam due to an important situation. It is up to the professor's discretion to give you a make up exam.

Attendance

You can only miss this class 3 times; after this, you will be droped from the class without further notification. if the professor doesn't drop you by the deadline, you will still receive a grade of 'F' for the class at the end of teh semester. To avoid this, keep in touch with your professor by email, if you have an emergency. It is up to the discretion of the professor to excuse any absence or not.
