Course Description

This course operates as the student media production team *MNG Media*. Students in Advanced Media Production I & II collaborate across levels to create professional media content while developing advanced technical and storytelling skills.

Working in production teams under student leadership roles (producer/director, executive producer), as well as through individual assignments, students will gain experience in:

- Short film and documentary production
- Newscast and feature reporting (sports, news, investigative, and entertainment)
- Podcast development and audio storytelling
- Studio and field-based program production
- Social media video and digital campaigns

MCOM 4363 (Advanced Media Production II) students build on prior experience by developing and executing more complex technical projects. Returning students work with the instructor to set individualized goals for the semester that strengthen professional skills and prepare them for entry into the media workforce.

Each student will complete a variety of single and team productions designed to give a hands-on study of advanced production techniques including: media packages, studio productions, multitrack audio editing, short films, and event/performance based projects.

Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. In those classes where attendance is considered as part of the grade, the instructor should so inform students of the specifics in writing at the beginning of the semester in a syllabus or separate attendance policy statement. An instructor who has an attendance policy must keep records on a daily basis. The instructor must give the student a verbal or written warning prior to being dropped from the class. Instructor's records will stand as evidence of absences. A student with excessive absences may be dropped from a course by the instructor. It is your responsibility to have (or have access to) a working computer in this class. ****Assignments and tests are due by the due date, and personal computer technical difficulties will not be considered reason for the instructor to allow students extra time to submit assignments, tests, or discussion postings.*** Computers are available on campus in various areas of the buildings as well as the Academic Success Center. ****Your computer being down is not an excuse for missing a deadline!!*** There are many places to access your class! Our online classes can be accessed from any computer in the world which is connected to the internet. Contact your instructor immediately upon having computer trouble. If you have technical difficulties in the course, there is also a student helpdesk available to you. Instructor Class Policies

Each student will be allowed 2 absences for any reason. If you are to be absent on the date a project is due, you must still turn your project in on time. Beyond these two absences, the student will lose 10% of their final semester grade for any absences for any reason that is not university approved. Missing a production day will result in a failing grade on that production.

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester. HOWEVER, if the student received financial aid (federal/state/institutional grants, loans and/or scholarships), all or a portion of the refund may be returned to the financial aid programs. As described below, two formulas (federal and state) exist in determining the amount of the refund. (Examples of each refund calculation will be made available upon request).

The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
