**COURSE DESCRIPTION:** Live theatre sharpens your perceptions while enhancing your creative capabilities. This course will cover realistic acting styles through scene work, will introduce acting pedagogues through group projects and exercises, will contain intimacy training and safe partner practices and expectations, and will contain an auditioning/portfolio assignment. This course requires the students to warm-up daily, prepare multiple performance projects, and actively participate in daily activities.

**COURSE OBJECTIVES:** To provide the student, through participation and experience, with an understanding and appreciation of the arts and theatre. Students will:

- Further develop research skills necessary to create a character who may be from a different time, place, culture, and lifestyle than the student
- Realize various acting techniques through 2 scenes and 2 monologues
- Develop oral and written critical skills for discussing performances observed
- Use constructive criticism to further develop an acting role
- Delve deeply into advanced acting techniques to continue to finesse professional skills and learn how to apply them into employment.

**TEXTS:** No textbooks are required for this class. However, you will be expected to read six plays, as assigned by the instructor. You will receive links to these as they become available.

Monologues and scenes from scripts, provided by instructor and student

**ATTENDANCE AND LATENESS:** This is a performance-based class. Attendance and punctuality are mandatory. The work of this course primarily happens during class time and cannot be made up privately. Tardiness is extremely disruptive and disrespectful to the creative process in an acting class. If you are absent or late, the following penalties apply.

Attendance Penalty Scale

0 absences + 20 points

Lateness

Late – 5 points  
Really late (over 25 minutes) – 10 points  
More than ½ of class – whole class

If students are sick/quarantining, they can still receive class credit/attendance points by attending the synchronous class via Zoom. They will be required to be present, dressed, have their camera on during the whole class period, and to do all exercises. Students MUST arrange for online classes 24 hours in advance with their instructor. Classes will NOT be recorded for students to view at any time; the student must be present for the class period as scheduled by the university. The Zoom link for class attendance will be given when requested by the student.

I DO NOT accept late work. If you have an excused absence, the homework must be turned in via email the date and time it is due, NO exceptions. If you are set to perform on a day you are missing due to an excused absence, you must exchange with a peer and it must be preapproved BEFORE the day of performance.

### **COURSE REQUIREMENTS:**

1. **PARTICIPATION:** Daily participation in class activities and discussions. Have fun, be engaged and participate fully in order to gain insight about yourself and develop your craft. Dependable participation in scenes, attending out of class rehearsal as needed.

2. **READING:** Completely read three assigned plays and demonstrate analytical skills. The Instructor will place three scripts on D2L. There will be quizzes on assigned reading. Student will also read and analyze the corresponding play for every performance project assigned (3 plays total). Student will be responsible for finding the scripts performance projects are from. This encompasses 6 total plays the student will read over the scope of the semester.

3. **PRODUCTIONS:** View 2 Midwestern plays *The Glass Menagerie* and *Peter and the Starcatcher* and write a critique. These will be based on acting critique guidelines provided by the instructor. These must be TYPED, EDITED and 2 pages in length in Standard English with an introduction and conclusion. Failure to see a required play will result in a 100 point penalty. Your ticket is free to both of these shows with your validated Midwestern Student ID.

4. **PERFORMANCES:** Prepare and present all performance projects, as assigned by the instructor. These include:

1. **Scenes:** Students will have two scenes assigned to them to memorize, rehearse, and perform. Some may be required to be performed more than once. You must submit a typed script analysis of 2-3 pages on your assigned in class performance day. **No late script analysis will be accepted.**
2. **Monologues:** Students will be required to prepare one monologue of material that is new to them, and also will revisit a monologue they have already performed for a self-tape exercise. You must submit a typed script analysis of 2-3 pages on your assigned in class performance day. **No late script analysis will be accepted.**

For both the scenes and monologues, a list of suggested plays will be provided by the instructor (if requested), or you will be assigned a role.

5. **RESEARCH PROJECTS:** Students will be assigned an acting practitioner and research their history, any stylings, and their contribution to the genre. Prepare a short informational PowerPoint

to teach to the class based on your findings. A five page paper will also be required.

Students will also be putting together a professional acting resume, acquiring a headshot, and creating a professional brand including social media and website. All information for this project will be given with plenty of notice for student to acquire materials and complete the project.

**GRADING:** Grading will be out of a total of 1500 points, based on the course requirements outlined above. You could at any time calculate your grade if you are organized and keep all of your assignments (which is a GREAT idea!)

**GENERAL NOTES:**

Scientific data shows that being fully vaccinated is the most effective way to prevent and slow the spread of COVID-19 and has the greatest probability of avoiding serious illness if infected in all age groups. When attending theatre performances and class arrive on time, be attentive, quiet and respectful during performances.

Please note that there may be adult themes discussed, addressed, and explored through both script reading and acting scenes in this class. The instructor will be sensitive to all viewpoints, and also allow for free speech and expression. Student safety is the instructor's first priority. Feel free to discuss with her at any time.

Changes in the course syllabus, procedure, assignments, and schedule may be made at the discretion of the instructor. You will be notified of any changes as they occur.

#### Cell Phones and Other Recording Devices

The use of cell phones and other recording or electronic devices is strictly prohibited during class.
