Course Description

This course uses the principles of Sanford Meisner, Stella Adler, and Michael Chekhov. Actors will continue their studies in living truthfully under heightened and imagined circumstances. Students will be introduced to how to emotionally prepare to enter a scene. These techniques will be applied to monologues and scene work.

Continued enrollment in the course constitutes a formal agreement to abide by all policies and procedures that are outlined in the syllabus.

Desire-to-Learn (D2L)

Extensive use of the MSU D2L program is a part of this course. Each student is expected to be familiar with this program as it provides a primary source of communication regarding assignments, examination materials, and general course information. Attendance

Students are expected to attend all meetings of the classes in which they are enrolled. The instructor must give the student a verbal or written warning before being dropped from the class. Student with excessive absences may be dropped from a course by the instructor. After three unexcused absences, each additional absence will result in the student's grade lowering by one letter grade. Unexcused versus excused absences will be determined at the professor's discretion. Missing or no-call/no-showing a private coaching session will negatively impact your grade even further in a SIGNIFICANT way. Additionally, arriving late to class on multiple occasions will equal absences at the instructor's discretion. Always arrive on time and be prepared to stay the entire time scheduled for the course. This is a performance-based class. Attendance and punctuality are mandatory. The work of this course primarily happens during class time and cannot be made up privately. Tardiness is extremely disruptive and disrespectful to the creative process in an acting class. If you are more than 10 minutes late or leave more than 10 minutes before the end of class, you will be counted absent for that day. If you expect to be more than 10 minutes late do not come to class. It is disruptive to your classmates.

Inclement Weather Policy

If the university is closed due to inclement weather, our class will not meet in-person or virtually. However, asynchronous assignments may be given so students are still expected to check their email and D2L for updates and instructions.

Cell Phones and Other Recording Devices

The use of cell phones and other recording or electronic devices is strictly prohibited during class.

Safe Zone Statement

Change of Schedule

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees, and room/board charges that were paid to MSU for the semester. Smoking/Tobacco Policy

Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License-to-carry permit, and openly carrying handguns is not allowed on college campuses.
