- Engage in a writing process that includes invention, drafting, and revision
- Write thesis-based academic arguments that provide strong support and specific details
- Find, evaluate, and synthesize credible sources in support of a research paper
- Use sources ethically and in contextually appropriate ways and follow a designated style guide
- Demonstrate proficient use of Standard Written English

Submission Format and Policy

- All writing assignments must follow MLA format. You may complete blue book writing assignments in pen or pencil. Type all out-of-class writing assignments. You will submit your research project and all of the semester's work in a three-ring binder with four properly labeled dividers: Handouts/Homework, Papers/Essays, Sources, Research Project.
- Do not send assignments as email attachments. Submit all work during class time on the due date unless otherwise noted on the assignment sheet.
- You may not submit a paper for a grade in this class that already has been (or will be) submitted for a grade in another course, unless you obtain the explicit written permission of me and the other instructor in advance.
- By enrolling in this class, you expressly grant MSU a "limited right" in all intellectual property created by you for the purpose of this course. The "limited right" shall include but shall not be limited to the right to reproduce your work product in order to verify originality and authenticity and for educational purposes.

Writing Center

Begin drafting papers as early as possible and take advantage of the MSU Writing Center, located off the 2nd floor atrium of Prothro-Yeager. Plagiarism Policy

Plagiarism is the use of someone else's thoughts, words, ideas, or lines of argument in your own work without appropriate documentation (a parenthetical citation at the end and a listing in "Works Cited")—whether you use that material in a quote, paraphrase, or summary. It is a theft of intellectual property and will not be tolerated, whether intentional or not. At the least, plagiarism will result in a 0 on the assignment; at worst, the consequence will be an automatic F for the course. I will follow the reporting procedures required by the dean of students.

Grading

Your grades in this class are based on this scale: A=100-90%; B=89-80%; C=79-70%; D=69-60%; F=59-0%. According to MSU's Undergraduate Catalogue, "letter grades have the following significance: A indicates excellent work, B indicates good work, C indicates satisfactory work, D indicates passing work, F indicates failing work" (73). Consequently, an essay that meets the basic requirements earns a C, not an A or B. If you wish to earn As and Bs, you will have to work hard to produce better than satisfactory, or average, writing.

Important: A final grade of C or better in ENGL 1143 is a requirement for graduation from MSU.

Homework

Homework assignments are readings from the two textbooks and materials in D2L. Their due dates are listed in the schedule that follows. Homework is due at the beginning of class.

Blue Book Essays

You will write three blue book essays during class. After completing a reading assignment, you will bring a blue book to class, and I will give you a writing prompt. You will use the class time to compose an essay using information from the reading and the rhetorical skills that have been covered in class. Blue books #1 and #2 are each 5% of your grade.

Papers

The Issue Proposal Paper and Exploratory Paper are written outside class. Their instructions are on D2L, and their due dates are in the course schedule that follows. These papers are building blocks for the Research Paper. Each is 10% of your grade.

Research Project

The Research Project is the focus of the semester's work. The issue and exploratory papers lead up to it, and the oral presentation reflects on it. Instructions for this project are on D2L, and its due date is on the course schedule that follows. This project is 40% of your grade.

Final Exam

The final exam is the 3rd blue book. The final will be given on Wednesday, May 8, 2019 from 1:00-3:00 PM. The final is 10% of your total grade for the course.

Extra Credit

I give no extra credit in this course.

Late and Make Up Work

- I will not collect late homework; however, you may include it in your binder for half credit.
- Missed group work and class work cannot be made up.
- A missed blue book essay must be written during my office hours. For example, if you are absent on Tuesday, February 5th, you will come to my office (BW 233) within one week to complete Blue Book #1. No appointment is necessary. Work not completed in this time frame receives a grade of zero.
- An assigned paper is due in class on its due date. I will reduce its grade by 10% for each weekday that it is late. So bring it to my office as soon as possible.
