## **COURSE OBJECTIVES:**

This course will assist you in developing and demonstrating:

- 1. An understanding of the various movements within the history of theatre. [Department learning outcome: Knowledge of the development of theatre]
- 2. Proper use of theatrical vocabulary. [Department learning outcomes: Theoretical/conceptual knowledge and application, and employability]
- 3. A firm knowledge of the roles of the various artisans as well as the role of the spectator. [Department learning outcomes: Theoretical/conceptual knowledge and application, and professionalism]

# **COURSE REQUIREMENTS:**

To succeed in this course you will need to ensure the following requirements are met, daily.

- Daily participation in all activities. Foundational information is given and explained in class and then built upon over the semester. Absences will cause many issues as you move forward in this course.

The class involves lectures, participation in classroom discussions, attending one (1) theatre production and writing one (1) response paper, three (3) exams, potential pop quizzes, and the Final Exam Project. In order to be a quality participant in class, you must READ THE CHAPTER ASSIGNED <u>BEFORE</u> COMING TO CLASS. (A calendar for this course is included in this syllabus.) You are expected to be an <u>active</u> and <u>positive</u> presence in class discussions. If I start to notice that class participation is lacking, the class will be given an impromptu quiz on the chapter.

### **CONDUCT STATEMENT:**

Behavior that interferes with either the instructor's ability to conduct the class or the ability of other students to benefit from the instruction will result in the instructor's removing the disruptive student(s) from the class, either temporarily or permanently (instructor drop), and receive a final lower grade, up to an F. In addition, and depending on the nature of the behavior or conduct, the student(s) may be subject to further disciplinary actions as per MSU policies.

#### PREPARATION FOR CLASS:

PLEASE remember to turn off (or to SILENT, <u>not vibrate</u>) your mobile phones before class begins. Because most of the important learning for this course occurs in class, it is essential that you be PRESENT AND ON TIME. Roll will be taken every class period. You are allowed two (2) days of absences, if necessary. With your third absence, your FINAL GRADE will be lowered by half a letter grade. With each subsequent absence, your FINAL GRADE will continue to be lowered by half a letter grade. If at any time excessive absenteeism (over five [5] absences total) is adversely affecting the work of others or your own work, you will be dropped and subsequently, failed from the course. Further, it is your responsibility to know what happened in class on any day you are absent and to be prepared for work on the day you return. If you have an absence on a day paperwork is due, you will NOT be allowed to make up any paperwork, and will fail that assignment.

However, if you have any planned excused absences (e.g., a school obligation), the paperwork must be handed in BEFORE the day it is due. ## **PERFORMANCE REVIEW PAPERS:**

You will be required to write **one (1)** paper based on your response to the production you will be seeing. Electronic copies of papers are due to D2L on the TUESDAY after a production's full performance run. All papers must be a **minimum of three (3) pages (maximum of five [5])** in length using one-inch margins, double-spaced in 12-point type Times New Roman or equivalent. They **must** be typewritten – **handwritten papers will not be accepted**. Please note **LATE PAPERS WILL NOT BE ACCEPTED** (this **includes** e-mailing them outside of class to me). If your paper does not follow the above format, I will give you a failing grade, so please make sure you follow the rules above.

Please use the following guidelines in writing your paper:

- In the initial paragraph, describe your overall response to the play. Did it have an impact on you? How did it impact you? (For example: Did it make you think about an interesting or new idea, did it remind you of something personal, was it artistically interesting, did it entertain you, or make you laugh or cry? Why?)
   PLEASE, UNDER NO CIRCUMSTANCES ARE YOU TO GIVE ME A PLOT SUMMARY OF THE PRODUCTION.
- Your THESIS statement is the LAST sentence of the FIRST or SECOND paragraph.
   It is the all-encompassing sentence; it is what your paper is truly about. (For example, "The Miser and all its theatrical elements gave me a greater appreciation for Molière and his time period.")
- The rest of your paper needs to support your thesis statement. You should address the following elements: acting (What did you think?), directing style (Did you think the movement or blocking on stage was smooth? Did it tell the story properly?), writing (What was the playwright trying to tell his/her audience?), and the play itself (What do YOU think the play is about?). Basically, you should incorporate all of the aforementioned collaborative aspects that go into a

production to support your thesis statement. In essence, did you feel there was a collaborative unity to the production?

All papers are expected to conform to the proper usage of the English language, including attention to spelling, grammar, complete sentences, and logical paragraph construction.

## **REQUIRED FINAL EXAM PROJECTS:**

**Produce a One-Act Virtual Play.** You will be assigned to groups of three or four, depending on our class size. A preliminary discussion with me is required before beginning your project. You will choose from a selection of plays I will provide; no group can do the same play.

Everyone must have an ACTIVE role in the final exam project; s/he may be a casting director, costume designer, or set/props designer. ALL of those involved must complete a virtual production meeting log for EACH and EVERY virtual production meeting s/he <a href="https://example.com/attended">attended</a>, and submit them via D2L. The Virtual Production Meeting Log Template will also be posted to D2L. <a href="https://example.com/please-follow-it-exactly">Please follow-it-exactly</a>. Depending on your position, you will HAVE to submit different materials. For example, the casting director will have to submit three (3) top actor choices for each character and their reasoning behind those choices. For the designers, they will have to submit colored renderings/pictures of their designs, as well as research they had to do for the project. Please cite all sources in a bibliography using MLA format.

Virtual production meetings should meet <u>outside of class</u>. Please remember, THIS IS YOUR FINAL EXAM. In the past, students have made the mistake of not taking this assignment seriously. Unfortunately, their grades reflected as such. **Paperwork for your Final Exam Project is due Wednesday, April 28<sup>th</sup> by 5:45pm to D2L.**
