### **Change of Schedule**

## **Assignments**

### **Discussions-Flipgrid**

This course also requires the use of FlipGrid. FlipGrid can be accessed by laptop or cellphone (iPhone or Android). The format of FlipGrid is like Snapchat in that you will be recording and sharing short videos of yourself with the class. You will also video reply to the videos of others with your comments. I know it can seem intimidating to record yourself, but we are going to become a close-knit educational community in a short amount of time! Please trust the process. The instructions for each Flipgrid discussion will be in each week's topic. The topic link will be in the week's module. You will be required to respond to two classmates. Professional and respectful decorum will be expected.

### **Journal Entries**

You will create a weekly journal to reflect on your thoughts, feelings and observations of the weekly course material. Each journal entry must be at least 300 words and written in APA format. No cover page is required, but please use appropriate citations when referencing sourced material. Your journal entries should be honest, thoughtful, and well-written. Use specific examples, evidence, or references to course materials to support your reflections.

#### **Evaluation Criteria:**

- Depth of reflection and critical thinking demonstrated in journal entries.
- Engagement with course materials and relevant real-world examples.
- Clear connections made between different social issues and themes.
- Quality of final reflection and synthesis.

#### **Part 1: Setting Up Your Journal**

- Create a digital or physical journal where you can document your thoughts and reflections throughout the course. You can use a notebook, a blog, a word document, or any other medium that suits your preferences.
- Provide a brief introduction to your journal. Explain the purpose of the journal, its intended audience (e.g., yourself, your instructor), and the social issues you expect to explore.



## **Part 2: Weekly Entries**

- After each class session or reading assignment that covers a specific social issue, write a journal entry reflecting on what you've learned. Consider the following questions:

## **Personal Theory of Leadership Project**

## **Part 1: Theoretical Overview**

- Research and provide a concise overview of at least three prominent theories of leadership. These could include Trait Theory, Behavioral Theory, Transformational Leadership, Situational Leadership, Servant Leadership, or any other relevant theories.
- For each theory, explain its key principles, underlying assumptions, and the type of leadership style it emphasizes.

## **Part 2: Comparative Analysis**

- Choose two theories of leadership from your overview and compare and contrast them. Analyze their strengths and weaknesses and discuss the situations in which each theory might be most effective.
- Provide real-life examples or case studies to illustrate how leaders have applied these theories to achieve their goals. Highlight any challenges they faced and how their leadership style contributed to addressing those challenges.

## **Part 3: Application and Reflection**

- Imagine you are a leader in a real or hypothetical organization. Based on your understanding of the theories, discuss which leadership theory aligns most with your personal leadership style and explain why.
- Reflect on the limitations of the theories you've studied. Are there any aspects of leadership that these theories might not adequately address? How might future leadership theories build upon or address these limitations?

## **Part 4: Contemporary Leadership Challenges**

- Identify two current or emerging challenges that leaders face in today's rapidly changing world. These challenges could include issues related to remote work, diversity and inclusion, ethical decision-making, or navigating technological disruptions.
- Apply the principles of one or more leadership theories to propose strategies for addressing each challenge. Discuss how these theories can help leaders adapt and respond effectively.

## **Part 5: Recommendations for Change**

- Synthesize the document and put it together with parts I-IV
- Write an introduction and conclusion.
