#### Welcome

The following information will explain the requirements for this course= individual voice instruction. Lessons re taught one-on-one, hence they are individually arranged at mutually acceptable times. The object is simple: to learn how use your voice in the freest, most expressive manner possible. Voice training is a long, arduous process fraught with difficulties. However, amazing progress can be made if we work together to understand the natural physical laws which govern vocalization.

# **Course Description:**

Although we will be spending a good deal of time vocalizing in lessons, the objective is to learn to communicate effectively to others through the singing of literature. It is therefore mandatory that you quickly learn the literature assigned. Your homework will consist of memorizing songs and vocalizing. Most vocalizing will take place during scheduled lessons.

**Course Objective:** The main objective is to learn how to sing, demonstrating a reasonable command of vocal technique, language and stylistic accuracy, acceptable vocal quality and overall musical intelligence.

### Repertoire:

Five songs will be assigned for the semester.

Grading Policy: All of the assigned songs will be required to be memorized. If not memorized the grade will reduce by one letter the week of juries. The student will choose one song to sing for the jury and one chosen by the vocal panel. Each song not memorized by jury time will result in a lowering of one grade each.

**Upper-Level:** Voice majors may not begin junior-level courses (3000) until passed to upper level. At the conclusion of the 4<sup>th</sup> semester of study, the student must meet specific requirements in order to proceed to upper-level (see student handbook). For the jury examination, the student must have at least 5 songs memorized in at least three languages. The student must show promise of future success as demonstrated by command of vocal technique, beauty of tone quality, language and stylistic accuracy, musical intelligence, artistry and stage presence.

**Attendance:** Students are expected to be present for all lessons. In the event of illness or unavoidable delay, please call my office at 940-733-2161 before you scheduled lesson Two unexcused absences will lower the final grade by one letter- four unexcused absences, two letter grades etc. A student with excessive absences may be dropped from the course by the instructor.

**Academic Dishonesty:** Cheating, collusion, and plagiarism (the act of using source material of other persons, either published or unpublished, without following the accepted techniques of crediting, or the submission for credit of work not the individual's to whom credit is given) is prohibited. Additional guidelines on procedures in these matters may be found in the Dean of Students' Office.
