## **Course Description**

A course designed to increase the variety and depth of the student's exposure to music and to enhance understanding and enjoyment of listening to music as an art.

## **Course Objectives and Student Learning Outcomes**

Student Learning Outcomes (SLOs):

- The student will learn to actively listen to pieces of music and analyze them for a more meaningful understanding and appreciation rather than a basic emotional reaction.
- 2. The student will learn to identify music according to the time period in which it was written.
- 3. The student will learn to listen through the different elements of music and identify the important characteristics of each piece.
- 4. The student will learn to holistically approach music with textual, dramatic, and programmatic elements to gain a deeper understanding of the composer's intentions.

#### **Curriculum and Materials**

The required book for the course is *Take Note* by Robin Wallace. You are also required to purchase access to the interactive Dashboard that correlates with the text. The MSU bookstore should have this package available. ISBN 97801993853881.

#### Homework

## **Mid-Term Exam**

The mid-term exam is an in-class exam covering chapters 1-7.

### **Final Exam**

The final exam is an in-person comprehensive exam, encompassing all the chapters of the book and the core repertory. In addition, the exam will include listening pieces not covered in the core repertory which you will be expected to discuss using the process of listening analysis you learned throughout the semester. The exam will be administered Tuesday, December 10, from 1:00 to 3:00 pm.

#### **Instructor Class Policies**

#### Academic Dishonesty

Academic dishonesty including plagiarism and giving or receiving unauthorized assistance is prohibited. Plagiarism is (1) the use of source material of other persons (either published

or unpublished, including the Internet) without following the accepted techniques of giving credit or (2) the submission for credit of work not the individuals to whom credit is given. If a student in the class plagiarizes material, appropriate disciplinary action will be taken. The Student Honor Creed developed and adopted by the MSU Student Government reinforces the discouragement of plagiarism and other unethical behaviors. The first statement of the creed reads, "As an MSU student, I pledge not to lie, cheat, steal, or help anyone else do so." Plagiarism is lying, cheating, and stealing.

In this course, the use of generative AI tools (such as ChatGPT) is not permitted. If the professor of this course suspects that an assignment contains AI-generated or plagiarized content, the student will be informed by email and have 5 days to schedule meeting to discuss the content. If the student fails to respond, no credit will be given for the assignment. Two or more zeros issued for suspected academic dishonesty will result in the automatic failure of this course.

#### Student Conduct

Behavior that interferes with either the instructor's ability to conduct the class or the ability of other students to benefit from the instruction will result in the instructor removing the disruptive student(s) from the class, either temporarily or permanently (instructor drop), and assigning a final lower grade, up to and including an F. In addition, and depending on the nature of the behavior or conduct, the student(s) may be subject to further disciplinary actions as per MSU policies.

## Privacy Statement

#### **Change of Schedule**

## Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees and room/board charges that were paid to MSU for the semester.
