## Course Description

CHEM 1243 is a second semester chemistry course to satisfy lab science requirements for BS majors and provide entry level information for students wishing to pursue other chemistry courses. The content covers basic chemistry concepts, calculations, and background for future courses such as organic, analytical, environmental, and biochemistry. This is a survey course and a continuation of CHEM 1143. Highlights and introductions to various specific and applied concepts will be covered in several areas relating to different aspects chemistry. This course covers intermolecular forces, phase chemistry, aqueous concepts and calculations, acid base, kinetics, thermochemistry, and nuclear chemistry.

## Quizzes

Quizzes will be given each week except exam weeks. These are not "pop" quizzes. Study for content, application and calculations related to the material

covered. All quizzes will be given in class to simulate a test environment and to test true knowledge and not Google research skills.
