Course Description

The purpose of this course is to examine the growing prevalence of civil liability within the U.S. Criminal Justice System. This course will explore civil liability issues for both U.S. law enforcement and corrections officers. This course will cover the increase in civil litigation in the U.S., the distinctions between civil and criminal law, and the primary foundations for civil liability under both state and federal law, as well as the damages that may be recovered. This course will also cover defenses to civil liability within the criminal justice system. Particular emphasis will be placed on lawsuits based upon 42 U.S.C. Section 1983, and the use of force in both law enforcement and corrections. The course will teach students to integrate this knowledge through examination of detailed case studies of the actions of both law enforcement and corrections professionals in the U.S. Criminal Justice System.

Critical Thinking Questions

You will have a critical thinking question each week, for the first half of the semester. You must respond to the question, then respond to two of your classmates' questions, in order to receive full credit. Participation is mandatory. Please do not hesitate to ask if you have questions, comments, or concerns. Some topics will be taking from "today's" news and issues.

Exams

Two exams will be given during the semester, as well as a final exam. Exams will cover material from the assigned readings and critical thinking questions (for which topics covered may not be in the book, but they may be taken from the critical thinking questions), up to that point in the course. Any material contained in the assigned readings may be tested. Likewise, any material sent to your D2L email, whether or not contained in the assigned readings, may be tested. The final exam will cover the semester, but you will receive a study sheet for the final

so you will know what to study. Make-up exams for Exam I and II will only be offered in extreme circumstances, at the professor's discretion.

Projects Required

The second half of the semester will be spent completing a PowerPoint online "presentation." Each presentation will cover a special topic in civil liability, as chosen by the student, or assigned by the professor. You will be given ample time to gather information for this assignment, as well as instructor input and guidance. The task for each student is to research the assigned material or topic and present these findings via PowerPoint presentation. The presentation should cover all major concepts of the material, as well as any relevant case law. I will provide you with a sample at the time of the assignment.

Final Exam

The final exam will be available on Monday, December 4^{th} at 7:00 AM, and availability ends December 9^{th} at 11:50 PM @11:50 PM. The final exam makes up 20% of your grade for this course.

Late Work

Students are expected to submit assignments on or before the due date. Late assignments will not be accepted unless prior arrangements have been made with the professor. Otherwise, students will not receive any credit for an assignment submitted after the due date.

Make Up Work/Tests

Makeup assignments and/or tests will only be allowed in extreme circumstances, and with the proper documentation. You are responsible for letting the professor know if you have any extenuating circumstances before the due date of the assignment/exam. In the event of an extenuating circumstance such as an illness, death in the family, etc., please get in touch with me as soon as possible. Assignments and deadlines may be modified on a case-by-case basis. Verifiable documentation of the circumstance may be required. The more quickly you let me know what is going on, the more options I will have for allowing you to complete the course.

Desire-to-Learn (D2L)

Extensive use of the MSU D2L program is a part of this course. Each student is expected to be familiar with this program, as it provides a primary source of communication regarding assignments, examination materials, and general course information. You can log into D2L through the MSU Homepage. If you experience difficulties, please contact the technicians listed for the program or contact your instructor. Remember, you are responsible for checking D2L email for any possible course-related information, or changes/updates to the course.

Attendance

Students are expected to participate in weekly assignments. You are also responsible for checking your D2L email at least weekly to receive study materials, changes to the course, etc. There will be occasions where I will ask that you respond to my email. Failure to do so will result in a lower participation grade for the course. Failure to check your D2L mail will result in missing assignments.

Change of Schedule
