Clinical Simulation Mock Exam

The Clinical Simulation Examination consists of 22 problems (20 scored items and 2 pretest items). The clinical setting and patient situation for each problem are designed to simulate reality and be relevant to the clinical practice of respiratory care. Candidates are given 4 hours to complete the CSE. To ensure that each Clinical Simulation Examination is consistent in content, the 20 scored problems cannot be chosen at random. Such factors as problem length, patient type, disease process, degree of difficulty and content tested by individual problems must be considered. A typical CSE will include the following: A. Four problems involving adult patients with COPD; e.g., pre/postoperative evaluation, critical care management, mechanical ventilation, pulmonary function evaluation, home care/rehabilitation, infection control. B. Three problems involving adult trauma patient; e.g., chest/head/skeletal injury, burns, smoke inhalation, hypothermia, C. Three problems involving adult patients with cardiovascular disease; e.g., congestive heart failure, coronary artery disease, valvular heart disease, cardiac surgery. D. Two problems involving adult patients with neurological or neuromuscular disorders; e.g., myasthenia gravis, Guillain-Barre, tetanus, muscular dystrophy, drug overdose. E. Two problems involving a pediatric patient; e.g., epiglottitis, croup, bronchiolitis, asthma, cystic fibrosis, foreign body aspiration, toxic substance ingestion, and bronchopulmonary dysplasia. F. Two problems involving a neonatal patient; e.g., delivery room management, resuscitation, infant apnea, meconium aspiration, respiratory distress syndrome, congenital heart defect. G. Four problems involving an adult patient with other medical or surgical conditions; e.g., thoracic surgery, head and neck surgery, carbon monoxide poisoning, obesityhypoventilation, acquired immune deficiency syndrome (AIDS). Passing score for the mock exam is 60. (Passing score for CSE is 73)

Exit Examination Passing Requirements:

All students are required to pass the National Board of Respiratory Care SAE (self-assessment exams) Therapist Multiple Choice Exam and Clinical Sim Exam as part of RESP 4432 Theoretical Applications and RESP 4102 Clinical Patient Management. Students may repeat the examination in the event that the exam is not successfully passed the first time. The student may retake the exam as needed to pass in order to graduate. Please note retaking the exam will be an additional cost to the student. If the exam is not successfully passed by the graduation date, the student will receive an Incomplete. The student has until the beginning of the next fall semester to pass the exam and remove the incomplete from their record. The student will not receive a diploma until they pass the Respiratory Care SAE (self-assessment exams).

The SAE (self-assessment exams) are mock RRT (registered respiratory therapist) exams that are given under true testing conditions. The exams are written by the same group that administers the actual exams graduates will be required to pass in order to obtain the RRT credential. *
