Course Objectives: This course is designed to provide advanced undergraduate psychology majors with an overview of the professional issues and responsibilities of clinical psychologists.

Course Description: While this course is basically a lecture course, it is hoped that students will read material ahead and will be prepared to engage in meaningful class discussion. Class lectures will be related to, but not identical with, material presented in the text, and you will be tested on both; therefore, regular class attendance is required.

Grades will be based on four equally weighted exams and four writing assignments. The exams will consist of both multiple choice and essay questions. One writing assignment will be turned in for each Section; the due date will typically be one week before the Section Exam. The first writing assignment will be a Vita and Letter of Intent for applying to graduate school. The second will consist of writing up the results of a clinical interview in an appropriate format. The third assignment will be a short APA-style paper about some type of psychotherapy, while the last assignment will be also be an APA-style paper on a specialty area of clinical psychology. This specialty area must be one that is not covered in the text; the specific topic must be approved by Dr. Guthrie.

Note: Late Writing Assignments will be penalized one letter grade per day.
