Course Description

A basic introduction to Physics 1144 is the first of a two-semester sequence of General Physics. Introduces the student to the concepts and principles of mechanics (kinematics, force, work, energy, momentum, rotational motion, elasticity, fluids, heat, and thermodynamics). In this semester we will discuss how all of these concepts and principles in Physics apply to day-to-day life. The lab component will help bring more meaning to the lecture. Observing and using the techniques and methods to do experiments and analyze data.

Pre and Post-Chapter Homework:

This is done before and after each chapter and has problem solving. Through Mastering, access code needed.

Labs

Labs will start the week of February 9. Everything will be provided to you in the lab, McCoy room 203, by your TA. Also, I will keep you updated via email.

This is an important part of the course. The experiments introduce you to the world of experimental Physics. You cannot miss more than two labs. If you miss the 3rd lab your grade will drop drastically by a letter grade and continue to drop a letter grade for every lab missed afterwards. Unless there has been an unforeseen circumstance like a medical emergency etc., have a medical or other valid excuse. Notify me prior to missing or no later than 24 hours after. Always keep me informed via email when missing labs and assignments etc. I will drop the lowest lab.

Questions

I will send solved questions after each chapter to use for study material on the exam.

Exams

There will be 5 exams from the chapters, in this semester. They are constructed of multiple choice, possibly true/false, and problem solving. The exams will contribute 60% of the final grade. There is no comprehensive final.

Final Exam

I will drop the lowest exam grade, but you have to take the final exam. The final exam must be at least 45/60 to be able to drop the lowest exam grade, but not the final exam. You must take the final exam. If you do not take the final exam, you will receive a 0/60 and add it with the other exams. I will not drop the lowest exam grade. This will greatly affect your final grade unless you have a valid excuse.

Extra Credit

There may be opportunities for extra credit during the semester, I will let you know if and when they become available. This is typically shared during class time.

Important Note

- I do not follow the grade on D2L, because I will post the grade after each exam to let you know where you are in this class. If you have any questions, please feel free to ask me about the details of your grade.
- Make sure to use your school email when contacting me. I do not respond to personal emails. Additionally, do not email me via D2L, please use my school email for any communication.
- Also, note that audio devices such as earphones, AirPods, and earbuds are not permitted during class or exam time.
- Be aware that any cheating will result in being dropped from the class.

Attendance

Attendance will be taken at the beginning of each class. Those that have missed 5 days of class, in the first four weeks of the semester, will be dropped on the 6th day with a WN (Withdrawn for Non-Attendance) and will not receive a W grade. Change of Schedule
