<u>CORRECTIONAL SYSTEMS AND PRACTICES</u>

SYLLABUS

CRJU 2243 Section 101 Fall 2020

COURSE DESCRIPTION: This course is an overview of the field of Corrections in Criminal

Justice. It includes the study of courts, sentencing practices, detention of offenders, institutions, probation, parole, juvenile services, and the death penalty. Exams will be based on both material found in the text, and instructor material presented in class, as well as any information gleaned from guest speakers or

field trips.

4. Understand the issues related to offenders moving through the correctional process

CONTINGENCIES:

The visit to Allred Prison Unit *may not be used* for this observation report.

15% AVERAGE GRADE OF SEVEN CHAPTER QUIZES (Drop lowest grade)

20% RESEARCH PAPER [Due 11/24/20]

Research paper must be computer generated (no handwritten will be accepted). Student should use <u>APA style</u> [consult bookstore for <u>College Style Sheet</u> (Furberg & Hopkins), or <u>The Little, Brown Handbook</u> (Fowler & Aaron), or the library circulation desk].

Research Paper must address <u>issues directly related to the field of corrections.</u> Paper will contain (1) a Cover page, (2) Abstract, (3) double-spaced, (4) five [5] to eight [8] page narrative text, (5) Works Cited (Bibliography). (6) <u>Paper must be well documented (citations of origin of source in narrative body of the text)</u>. (7) Research paper must include no less than eight (8) reference sources (Works Cited), of which four (4) must be since January, 2015. No more than two (2) *original* internet sources may be used. Publications found on the web should cite the <u>original published source</u> (newspaper, magazine, book, professional journal, etc.), and the original date of publication. In addition to the professional publications, the Works Cited sources may document utilization of materials from class notes, textbook, and correctional agency/court/field visit observation.

This "limited right" includes the right to reproduce the student's work product to verify the <u>originality and authenticity of the work.</u> Any evidence of plagiarism may result in failure of this course.
