Pre and Post-Chapter Homework:

This is done before and after each chapter and has problem solving. Through Mastering, access code needed.

Lecture/Study Homework:

This will have problem solving and be available after each lecture on D2L. This is for study use only, not for a grade. It will not be graded but the material will be used on the exams. Please do not ask for the answers, once I provide the answers, the question will not be used on the exam.

Labs

Have paper, pencil, and a calculator to do all labs.

This is an important part of the course. The experiments introduce you to the world of experimental Physics. You cannot miss more than two labs. If you miss the 3rd lab your grade will drop drastically by a letter grade and continue to drop a letter grade for every lab missed afterwards. Unless there has been an unforeseen circumstance like a medical emergency etc., have a medical or other valid excuse. Notify me prior to missing or no later than 24 hours after. Always keep me informed via email when missing labs and assignments etc. I will drop the lowest lab.

I will send solved questions after each chapter to use for study material on the exam.

Exams

There will be 5 exams from the chapters, in this semester. They are constructed of multiple choice, true/false, and problem solving. The tests will contribute 60% of the final grade. There is no comprehensive final.

Final Exam

I will drop the lowest exam grade, but you must take the final exam. The final exam must be at least 40/60 to be able to drop the lowest exam grade, but not the final exam. You must take the final exam. If you do not take the final exam, you will receive a 0/60 and add it with the other exams. I will not drop the lowest exam grade. This will greatly affect your final grade unless you have a valid excuse.

Late Work

Late work is unacceptable without a valid excuse. Please reach out to me to inform me so we can work together to avoid any loss of points.

Make Up Work/Test

There will be no make-up labs because the lowest lab grade will be dropped unless there is a valid excuse. If you miss an exam due to personal illness, emergency, or a school related activity, you will be allowed to take a make-up exam. It is your responsibility to schedule a make-up exam by contacting me via e-mail. You must contact me within 24 hours and schedule a time to make up the exam.
