Course Description

This course will introduce students to feminist rhetorical practices and provide students an opportunity to develop critical reading and rhetorical analysis skills. Students will examine the rhetoric of women's public and private writings about the home including cookbooks, advice columns, advertisements, letters, and journals. Students will engage in an archival research project.

Course Goals

- Acquire a basic understanding of traditional and contemporary rhetorical theory
- Acquire a deeper understanding of feminist rhetoric, including analysis of primary and secondary sources, and applications of theories and methodologies;
- Hone research skills and demonstrate ability to follow the MLA style guide;
- Gain experience in conducting rhetorical analysis and presenting research to peers.

All formal papers will run through Turnitin for an Originality Report and an AI Report. At the very least, plagiarism will result in an F on the assignment; at worst, the consequence will be an F in the course. Grading

For final grades, this class will not use the plus/minus grading system. The following numerical equivalents for final grades are used: A = 100-90%; B = 89-80%; C = 79-70%; D = 69-60%; F = 59-0. For individual assignment grades, an A+ = 98, A = 95, A- = 92; B+ = 88, B = 85, and so on.

Mid-Term Grades

In order to help students keep track of their progress toward course objectives, I will provide a Midterm Progress Report through Navigate. I will submit a grade for all students, not just those in danger of failing the course. Midterm grades will not be reported on your transcript; nor will they be calculated in the cumulative GPA. They simply give students an idea of where they stand at the midpoint of the semester. Students earning below a C at the midway point should make an appointment with me and consider visiting the Learning Center for tutoring services.

Late Work

Late assignments (defined as work not submitted by the date and time posted in D2L) will be accepted, but they will lose 10% of the final grade. If students are unable to come to class on the day an assignment is due, they should still upload their work into the D2L Dropbox folder on time to avoid late paper deductions.

Submission Format and Policy

All formal assignments are to be typed, formatted, and outside sources documented according to MLA style. All formal papers will be uploaded into the appropriate D2L Dropbox folder.

Attendance

It is important that students attend class and arrive on time. I will take daily attendance via an "attendance question" at the start of class. If a student accumulates more than three weeks' worth (TR 6 classes) of absences (excused or not) the missed instruction will make it difficult to excel in the class. Students who miss class will not be directly penalized, but they will miss out on opportunities for participation and explanations of assignments that could impact the final grade. Change of Schedule
