Instructor Perspective: Workload in this course will be moderate. Material may be new to the

student. Some concepts presented may be controversial. Do to the nature of the course, *some material may be personally offensive or very emotionally sensitive*. A career in the field of criminal justice or a closely

related area requires exposure to this information.

Today's society has liberalized acceptance of substance abuse, electronic games of violence, and free social media access to children of both adult and illegal sexualized content. Much of the material utilized in this course is developed from a social treatment and/or a child protective services perspective, adapted to meet the needs of criminal justice students entering the field. This course aids the student in a greater understanding of the nature of criminal behaviors involving children, birth to eighteen years.

**Course Description:** This course is designed to acquaint the student with the differing aspects

of crimes that are committed either against children, or crimes involving children. Among the topics discussed are physical abuse, sexual offenses, psychological manipulation of children, the legal aspects of dealing with crimes involving youth, family violence, school violence, and some of the actions society and professionals can use to prevent a higher incidence of

these acts perpetrated against children.

# 10% INTERVIEW WITH A 1) LAW ENFORCEMENT OFFICER, or 2) LEGAL SYSTEM PRACTITIONER, or 3) CPS PROFESSIONAL or 4) MENTAL HEALTH PROVIDER [due April 15]

Student should speak with a person who regularly deals with crimes against children. In written computer-generated report form (no handwritten), student should identify:

- 1) the name of the person interviewed;
- 2) the professional title of the person;
- 3) the regular daily routine of the person [job description];
- 4) how the person deals directly on their job with a crime against a child; and,
- 5) what the person's prognosis for the future is in terms of how society can better deal with crimes against children.
- 15% **CHAPTER ABSTRACTS** [due as assigned; no late submission over 7 days (reduced credit)] Summarize chapter readings in the following format:
  - A) the title and author of the assigned article;
  - B) the prevailing theme of the assigned reading;
  - C) the main points that the author relies upon to support his thesis;
  - D) your thoughts/evaluation regarding the issues dealt with in the article, and why you believe as you do.

### 20% RESEARCH PAPER [due April 24]

Requirements include 1) Cover Sheet, 2) Abstract, 3) four to eight pages of narrative, 4) 6+ Sources Cited including at least three since 2016; 5) APA style, 6) double spaced, computer generated. Any quotes from internet sources must cite the *original source* of the information. The paper should deal with the issues discussed in this course (i.e., at-risk children who are subject to having crimes committed against them, a specific type of a crime against a child, and/or the profile of the perpetrators of those criminal acts).
