#### **Course Description**

A Advanced course for the study of singers' diction. The International Phonetic Alphabet will be applied to German and French. A working knowledge of IPA is expected.

#### **Course Objectives and Student Learning Outcomes**

Upon completing this course, students will be able to:

- Know the symbols and corresponding sounds of the International Phonetic Language (IPA).
- Be able to sight-read IPA transcriptions of song texts in German and French.
- Practice effectively communicating text without compromising vocal freedom by understanding modifications and substitutions, diphthongs, semi-vowel glides, shadow vowels, merges, and implosions.
- Communicate text effectively through emphasizing words of primary and secondary stress, understanding the poetry, and learning the rhythm and melody of language.

#### **Curriculum and Materials**

The required materials for this course are *Diction for Singers* by Joan Wall and an appropriate French dictionary that uses IPA.

**Song Projects** This course will include 2 song projects: one English and one Italian. Students may consult their applied voice instructors for repertoire selection. Each project will consist of a prepared phonetic transcription and English translation as well as an in class performance.

**Exams** This course will have 2 exams. Each exam will consist of a written portion and an oral portion. An IPA transcription will be provided for the oral portion.

**Make-up Work/Tests** Any assignments missed due to absence may be turned in via email by the original due date. Late assignments may result in a grade deduction if not accompanied by proper documentation of illness or extenuating circumstances. Exams and performances may be made up if the student reports the absence via email before the time of class meeting.

### **Other Information:**

#### ***Disability and Accommodations***

In this course, the use of generative AI tools (such as Chat GPT) is not permitted. If the professor of this course suspects that an assignment contains AI-generated or plagiarized content, the student will be informed by email and have 5 days to schedule an online office hour via Zoom to discuss the content. If the student fails to respond, no credit will be given for the assignment. Two or more zeros issued for suspected academic dishonesty will result in the automatic failure of this course.
