July 2007—began serving as CO-PI for an HIV/AIDS Needs Assessment for the North Central Texas HIV Planning Council. The needs assessment covered 38 counties. This is a Ryan White HIV/AIDS Treatment Modernization Act of 2006 and State Service Funds Grant. Using qualitative methods, the study involved a comprehensive assessment of HIV+ individuals and their reasons for noncompliance with medical regimens. Training of students as well as data gathering and transcription occurred through the Fall semester, 2007. The grant ended in February 2008.
