Lubbock County Detention Center (LCDC) serves a county of 280,000 people in rural west Texas, as well as a substantial number of rural counties surrounding it. LCDC therefore must address the mental health needs of both the inmate population originating in Lubbock County, as well as the needs of surrounding counties that do not have appropriate resources to manage individuals with serious mental illness and substance abuse disorders. LCDC joined the Stepping Up Initiative in December 2016 as a commitment to reducing the prevalence of mental illness in its inmate population. However, the current infrastructure does not include integrated data or processes for assessing the effectiveness of these efforts. This project proposes to assess data capacity for existing databases and create an integrated data interface that will facilitate the evaluation of the effectiveness of existing policies and procedures. The planning and oversight team will inventory existing policy and use assessment of the integrated data to determine how mental health screening and diversion can be improved. Assessment and evaluation data will be compiled and presented to enumerate the need for a mental health court. Texas General Land Office.
