- Explore the finances of a university and college especially in regards to the various funding sources and how the resources are determined, constraints, opportunities, as well as, state appropriations for the public institution. Students will be able to describe the various revenues and

how they are determined. In-depth understanding of the public institution state funding formulas. Also, students will gain an understanding of how to read financial statements.

- Overview of budgeting basics in higher education and how to build longterm financial sustainability. Students will explore factors that promote financial health and identify the tension between competing factors.
- Understand the planning process from strategic plans to Quality Management practices.
- As talent management is critical to the success of any organization. As a high-touch, service industry, Human Resources is especially critical to the success of a university. Students will look at recruiting and retaining staff.
- Fundraising as a significant tool for obtaining resources for added investments in the quality instruction and student experience, students will explore concepts, roles and definitions regarding gifts, donations, grants, and other sources of planned giving.
- Future views of higher education and changes on the horizon that both threaten the university model we have today, and offer opportunities for the next generation of life-long learner and how best to serve students and the mission of the institution.

Course Assignments

Weekly Discussions and Chapter Activities: Students will participate in weekly discussions based on their reading and related research related to financial management in higher education. There will be 12 weeks where discussions will be graded with a maximum ten points awarded.

Leader Interview: Students will interview a leader in higher education and answer reflective questions about their learning from the interview.

Financial statement analysis: Students will review actual financial statements of university and colleges in order to perform a high-level analysis of key metrics and performance indicators.

Final essay: Students will draw upon their semester learning and write a thoughtful essay and personal reflection on key issues affecting the future of higher education.

Extra Credit

An extra credit project will be available at the end of the course for students wanting to earn further points.

The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
