# **Syllabus**

#### **Texts:**

Fish. How to Write a Sentence and How to Read One. Harper (978-0-06-184053-1) (Abbreviated Fish in class materials)

Kolln, Gray, Salvatore. *Understanding English Grammar*. Pearson (978-0-401418-0) (Abbreviated *UEG* in class materials)

### **Required Additional Materials:**

Access to word-processing and MS WORD

#### **Course Goals:**

Discussion and practice of techniques for the grammatical analysis of English sentence structures.

## **Course Requirements:**

To create the class grade, we will write four unit exams (for 80% of the grade) and compose a class-project essay (worth 20%)

When an exam is scheduled, you will receive from me, as e-mail attachment sent to your D2L address, a file containing the exam. You then will have twenty-four hours to open the file, type out your best answers, save those answers, and return them to me as an e-mail attachment sent to my MSU Texas address: robert.johnson@msutexas.edu. Given that exams will be written remotely, with access to the text, I will have to expect full, polished, and thoughtful answers, not cut-and-paste . In addition, exams will be sent in WORD format and must be returned in that same format. NOTE: We will discuss proper formats for sentence diagrams when we study chapter three in *UEG*.

# **Grading Policy:**

The final mark will be based on the total points earned: A = 100 to 90 points total; B = 89 to 80; C = 79 to 70; D = 69 to 60; F = 59 to 0. Please recall that, given our university's catalog definition, "satisfactory" written work will be awarded a C grade.

#### **Final Examination:**

We will have no comprehensive exam.

Typed, written work will be submitted in MLA format.
