Course

Description: Clinical practicum in the evaluation and management of orthopedic sports injuries and conditions with a specific focus on the lower extremity, lumbar, and thoracic spine. (Prerequisites: ATRN 2901, 2903. Co-requisite: ATRN 3803).

Student Outcomes:

1. Demonstrate and practice of the underlying principles and techniques of effective upper extremity, cervical and lumbar spine evaluation and assessment techniques.

2. Demonstrate the difference between the accuracy and reliability of the variety of special and functional tests as related to the evaluation process. Explain the difference between the evaluation and reevaluation process.

3. Demonstrate principles related to palpation, muscle function, capsular and ligament stress testing, joint play, neurologic and vascular function related to the evaluation of the upper extremity.

4. To facilitate critical thinking that involves application of current athletic training techniques and problem solving to upper extremity, cervical and thoracic spine evaluation and assessment techniques.

Utilize standard documentation procedures, terminology, and communication in the systemic evaluation and diagnosis of upper extremity, cervical and lumbar spine injuries. Perform a comprehensive lumbar spine, thoracic spine, cervical spine, and upper extremity injury assessment. This evaluation includes, History, inspection/observation, palpation, functional assessment, selective testing/special tests, neurological and circulatory assessments.
Assess and interpret findings from the physical exam. Use scales to determine patient outcomes.

Assignments:

Practical Quiz: Each major section will have a practical quiz to test your knowledge about the subject content. This will allow you to perform skills that you will need in the athletic training room. These must be scheduled with Gary during the week of and after the listed date. For example, a Practical Quiz is listed for the Foot & Toes on 10/1/2021. You must complete the practical on the week from 9/27/2021 - 10/1/2021. Yourself, a partner, and the instructor must be available for each practical. Allow at least 30 minutes per Practical Quiz. Each Practical Quiz is worth **50 points**.

Comprehensive Practical: The Comprehensive Practical will test your knowledge about the entire lower extremity. This test is scenario-based. The instructor will give you a short introduction, and you must complete the rest of the evaluation in a sequential order. You must ultimately give an assessment at the end of each scenario. You will receive 4 areas of the lower extremity to evaluate. Each scenario is worth 50 points, for a total of 200 points for the Comprehensive Practical. Yourself, a partner, and the instructor must be available for the Comprehensive Practical. You must schedule this practical during the week of finals. You need to allow at least 1 hour for the Comprehensive Practical.
