Assignments

Quiz= A quiz will be given for all major topics. The date of the quiz is listed in the Day-by-Day Outline. The purpose of each quiz is to test your knowledge of the information for each topic that has been presented thus far. Every quiz will be given at the beginning of the class period. **Quiz= 20 points**

Exam= An exam will be given for all major topics. The purpose of each exam is to test your knowledge of the information for each major topic. There will be a mixture of multiple choice, muscle chart, fill-in-the-blank, and essay questions for each exam.

Exam= 100 points

Comprehensive Exam= The final exam will be given during the week of May 11, 2023 8:00 AM. This will be a comprehensive exam over all information presented. The purpose of this exam is to test your cumulative knowledge about all topics of the Upper Extremity. It is important that you retained all information in this course in order to be an effective Allied Health Care Professional. There will be a mixture of multiple choice, muscle chart, fill-in-the-blank, and essay questions for this exam.

Comprehensive Exam= 150 points

Evidence Based Practice= It is the goal of the National Athletic Trainer's Association (NATA) to have all athletic trainers practicing evidenced based assessment and treatment. In order to stay current with practicing standards, you will need to write a 1 page paper on major topics throughout the semester. These papers must be a summary of an article from a scholarly journal to be approved by the instructor. Each paper will include a summary of the History, Methodology, Results, Authors' Conclusions, Student Conclusions, and Appropriate Usage. Your name, course number, date, and professor name must be listed at the top of the paper. This section CANNOT be double-spaced. However, the rest of the paper must be double-spaced. You must also provide a hard copy of the article you chose to be turned-in with the paper. No late submissions will be accepted of either the paper or the article. **Paper= 30 points**

Distinguished Lecture Series= Attendance at all lectures of the Allied Health Dignified Lecture Series is mandatory. Students who have conflicts with class schedules or clinical/field experience rotations may be excused from the presentation but must watch a recorded video of the presentation within the following week. Students will submit a written summary of each lecture. Students are expected to dress professionally. Each DLS is worth **20 points**.

"Each student must take and pass (75%) or better a **written/**practical Game Day exam. This test gives each student the opportunity to recall knowledge from previous academic semesters. The first opportunity to take the exam will be available during the first 2 weeks of the given semester. If the student does not pass the exam associated with this course, the student may re-take it once a week until the end of the semester. It is the student's responsibility to make arrangements with the Clinical Education Coordinator to schedule further testing. Failure to pass either exam will result in a failing grade for this course. Any questions about this process should be referred to the Student Handbook 2022-2023."
