Course Objectives:

- become familiar with movement terminology
- introduce the structures of the musculoskeletal system and how these structures interact to provide functional movement
- introduce joint classifications
- introduce skeletal muscle function and structures
- introduce neural centers and pathways controlling movements
- understand the advantages and disadvantages of certain musculoskeletal interactions
- introduce biomechanical concepts of the musculoskeletal system

Course Evaluation: Evaluation of the course material will be broken down between four (4) exams throughout the semester, five (5) quizzes taken on D2L, and ten (10) labs. Each exam will be cumulative as the information attained early in the semester will be relevant to proceeding material. All exams will be in person and worth 66% of your overall grade.
