Fall, 2020 Information: Welcome to the brave, new world. As you undoubtedly know, this is scheduled to be an in-person class; however, while you will be in-class, I will not. The way it is supposed to work is that I will connect to Zoom, through D2L, and someone will log into that meeting on the computer in the podium. That screen will then be broadcast to the screen at the front of the class and, voila!, there I am. At the beginning of the semester, the ability to be interactive will be somewhat limited because the good video camera and microphones will not have been installed yet, but that should happen soon; until then, we'll limp along and do the best we can.

As it works out, half of you will be in the classroom on Tuesday, and half of you will be watching remotely over Zoom. I would request that, when watching Zoom, please keep your camera on.

Folks, this pandemic is not a hoax, and not a laughing matter. It is killing a lot of people; let's try not to join that group. Wearing masks and maintaining social distancing is mandated by the State of Texas and Midwestern State University, and will be required for all students in this classroom. If you cannot wear a mask or keep your distance, you will not be allowed in the classroom. The main thing is to treat everyone with respect.

Final Exam: Tuesday, 12/10 at 8:00 - 10:00 a.m.

An optional, take-home final exam will also be offered. This exam is designed to give students who need/want to improve their grades an opportunity to do so. This exam does not replace the Final Exam, or any other exam; everyone must take Exams 1, 2, and 3, as well as the regular final. If you take the optional final, the grade will be counted in with all the other grades but, hopefully, this represents an opportunity to get a really good test grade. The optional final exam will be comprehensive, and will consist of 100 multiple choice questions. It will be available on 12/2/20 and will have to be turned in no later than the beginning of class on 12/10/20, at the beginning of the regular final exam. Late exams will not be accepted.

<u>Course Requirements:</u> Grades will be based on your performance on 3 exams, worth 100 points each. All exams consist of multiple choice questions, on Scantrons (Form 881-E). Exams are comprehensive *for that section*. Test content will be drawn from readings in the text <u>and from lecture material</u>. Not all lecture material will be found in the text, so regular class attendance is required.

**Midterm Exam:** By the midterm, you will develop a list of **three** theoretical perspectives in psychology. The purpose of this activity is to help you to 'think psychologically' about the world around you. You will be asked to list and describe each of these perspectives. These perspectives will then be used during the final exam to address a societal, interpersonal or personal problem. This portion of the exam will contribute **25%** toward your grade *on that exam*. Answers will be graded on (a) whether you listed three recognizable psychological perspectives, (b) the accuracy of your descriptions, and (c) the structural and grammatical adequacy of your answer.

**Final Exam:** A portion of your final exam will include an essay component that requires you to address an issue of social, interpersonal, or personal concern (e.g., an unproductive employee, a student who can't control his spending, religious intolerance) from the perspective of **one** of your psychological theories or perspectives listed at the midterm. This portion of the exam will account for **25%** of your grade on *the final exam*. Answers will be graded on (a) your ability to address the problem from one of the psychological perspectives, (b) the strength and accuracy of your argument, (c) your level of empathy, ethics, and respect for diversity in your response, and (d) the structural and grammatical adequacy of your answer.

Course grades are based on the number of points accumulated over the semester. There is a total of 300 possible points, so the grade ranges are as follows:

A = 270 - 300 points

B = 240 - 269

C = 210 - 239

D = 180 - 209

F = less than 180 points

#### RESEARCH REQUIREMENT

It is important that students of scientific psychology learn firsthand something about the scientific nature of the discipline. Therefore, all students in PSYC 1103 and 2203 are required to participate in one of the following research-related exercises. No extra credit is given for research participation, but failure to complete the research requirement will result in a one letter grade reduction for the course. The deadline for completing the research requirement is  $\frac{4}{30}$ .

1. Participate in one or more psychology research projects totaling at least 90 minutes. 2. Complete a research ethics essay. Participating students will read an article provided by me about research ethics. Following this, students will complete a 3 or 4 page double-spaced, typed summary and review of the information they read. Tables, figures, pictures do not count toward the minimum page requirement. Essays must be submitted no later than 4/30/20.

<u>Attendance Policy:</u> Students are allowed three (3) absences. Once you exceed this limit, whether the absences are excused or not, you may be dropped from the course with a grade of "F". I will not be responsible for recording attendance for students who are tardy.

<u>Make-up Policy</u>: You may make up <u>one</u> (1) missed exam: if you miss more than one exam, you should drop the course. A mass make-up for exams will be administered on Tuesday, 12/10 following the final exam. No other make-ups will be allowed; if you miss an exam during this semester, you must attend this session. Failure to do so will result in a grade of "0" on the missed exam.

<u>Cheating Policy:</u> Any evidence of cheating on exams will result in dismissal from this class with a grade of "F". To avoid questions of cheating, make sure you mark your Scantrons cleanly, and use a No. 2 pencil. No grade changes will be made because of "Scantron error."

<u>Note:</u> Individuals requiring special accommodation may contact me after class or during office hours.

<u>Also note:</u> Pagers and cell phones are to be turned off during class. If you have a situation that requires you to receive calls, you need to contact me ahead of time, have your device on vibration mode, and take the call outside the classroom.
