Course Description

This course introduces students to current issues in international politics and the global community. We will look at the impact that international interdependence has created within the political, economic, social, and environmental issue arenas. It is assumed students have limited prior knowledge of the topics, therefore this course allows students to develop an operational understanding of common world problems, and policies that have been created to address these issues. The first part of the semester sets the foundation by explaining the structure of the international stage and its key actors. The second part of the semester delves into the international economy, international law, and human rights. The third part of the semester completes the picture by analyzing some of today's emerging challenges, including environmental problems and changing political conditions. The syllabus provides a general plan for the course; changes may be necessary. Any changes may be announced in class and/or posted to D2L.

Learning Objectives:

- Identify key components of the contemporary international system.
- Discuss state sovereignty in the international system.
- Explain the existence and utility of international law, including identification of international judicial bodies and their functions.
- Understand the main organs of the United Nations and their functions.
- Identify at least one major regional IGO (EU, AU, OAS, ASEAN, etc.) in the international system and explain its goals and current status towards achieving those goals.
- Describe what an NGO is and identify the goals of major NGOs.
- Explain what a weapon of mass destruction is, present differing perspectives on policies and international treaties and regimes aimed at preventing the proliferation of such weapons, and articulate the position of those states that are trying to acquire such weapons.
- Define terrorism, present differing arguments seeking to explain the motivation of terrorists, and distinguish between terrorism and other forms of non-conventional warfare.
- Articulate the concept of human rights, including the history of the growth of human rights, and the major international treaties and conventions relating to human rights.
- Discuss the major environmental issues facing the international system, as well as efforts made to deal with these issues, and the positions and controversies surrounding environmental issues.
- Describe the flow of finances and technology in the international system, including the main characteristics of international trade, and the impact of such trade on economic development and standards of living.

Required Textbook & Instructional Materials:

- 1. Realizeit Adaptive Learning Courseware—this courseware embeds a text (Snarr and Snarr, "Introducing Global Issues"), the RCII database, and other learning materials. Realizeit subscription information:
 - a. If you are enrolled in the course in D2L, you are automatically enrolled into Realizeit, which is integrated into D2L.

Technical excuses for being unable to successfully do the coursework will not be accepted. You must complete all online course assignments using D2L between the specified times/dates listed in the weekly course outline below.

- A working webcam on the computing device used for the exam.
- Microsoft Office or a compatible program for written assignments. Access to Microsoft Office 365 available through the Office 365 for Students on the Microsoft website.

Please note: a limited number of webcams and laptops with cameras are available for check-out through the MSU Texas Moffett Library.

Office Hours:

Normally, office hours are an open invitation to walk into my office without appointment and discuss with me anything of concern related to the course. Due to the current Covid-19 pandemic, I will hold virtual office hours this term. See the top of the syllabus for my generally available times. I will schedule a virtual Zoom appointment with you we can talk, but also stay healthy with use of social distancing.

Communication:

The best way to reach me is by email. I will make all attempts to answer emails within 48 business hours unless it is over a holiday break. You must check your email listed as the primary account in your Banner information, as I will use this address to communicate with you outside of class. I will use D2L for posting syllabi, course communication, course schedule, attendance, and gradebook. There may be some online office hours announced through D2L, if they vary from the office hours posted above. You should regularly check D2L and the email hosted via D2L for important course information.

Attendance Policy:

This course has been planned as a fully face-to-face course for Fall 2020. As such, face masks are required to be worn in class at all times, per university policy. The class will meet in its regularly scheduled room but will utilize social distancing and an assigned seating chart. When the university transitions to fully online after Thanksgiving we will review during the last week of class and hold our finals virtually. In the event of increased incidence and risk of COVID-19 that results in the university moving back to a shelter-in-place mode, the course instruction will transition to fully online. More instructions will be given at that time.

I am required by the university to report failure to attend and complete assignments. I will randomly take inperson attendance and check for your D2L activity in our class on 10 random days during the semester. If you are absent, and haven't logged into D2L and completed work during that time, nor have you provided a legal or medical excuse for non-participation, your attendance grade will be marked as absent for that date. Class Attendance and Participation (10 points):

Class meets three times a week, for approximately 38 class dates. Participation is based on attendance AND participation in discussion in class. I expect you to talk during class, engaging with me as the instructor, and your fellow students. Science has shown we learn best by asking and discussing our questions about issues. I encourage questions, dialogue, and open debate, just do not monopolize class discussions. I randomly take attendance at 10 time points during the term.

Exams (3, 20 points each):

These are administered through D2L, and are a mix of multiple choice and open answer, essay-based questions. You will need to bring a laptop or tablet to class the day of exams to take the exam. If you do not have access to either of these, please see me to make alternative arrangements. The exam content is based on lecture content and readings (the textbook readings and additional readings posted on D2L). Each exam will feature material introduced since the last exam only. Anything I say in in the lectures, along with anything in the assigned readings could be used for the exams. The first two exams take place during the normal class period, and open at the start of class in D2L, lasting until class ends. The final exam will be taken off-site only, through D2L, and requires use of a laptop/tablet with a working webcam. CHROMEBOOKS WILL NOT WORK WITH THE EXAM SOFTWARE.

Realizeit Materials - Reading Quizzes, Map Quizzes, RCII Quizzes- (30 points):

Thirty percent of final grade will be determined by your completion of 12 modules (11 content modules and 3 map quizzes counted as a separate module). You will work on these modules through the Realizeit courseware (accessible through D2L by going through the various modules or "sections"). The purpose of providing you with this courseware is to provide an integrated system through which you will be encouraged to do the readings and test your knowledge and understanding of the various content chapters. The set-up of the courseware is as follows:

- Readings: Through D2L, you will click on the relevant section and it will immediately take you to the Realizeit site where you can access the various chapters assigned for your reading material (see full schedule below); read the text carefully; take notes, make annotations, underline important parts; jot down any questions you may have and ask them in class; you should spend on average 1½ to 2 hours per week going through the readings; these readings are the foundation for the reading quizzes (see below) as well as for the exams
- Reading Quizzes: There is a specific schedule listed below telling you when Realizeit quizzes must be completed. Each quiz will deal with questions related to specific chapters in the text so make sure you have done the reading, then enter the assessment through D2L (you may want to have two tabs open now, one for the reading and one for the assessment BUT you will not have enough time to check for answers in the reading if you have not actually yet done the reading); for each reading quiz, you will have 12 minutes within which to answer 12 multiple choice, matching or multi-select questions. You will have two attempts for each reading quiz and the highest score will be counted (but note that the questions are randomly chosen so your second quiz can have different questions from the first one.) After each module quiz due date ends, you will still be able to work on this material, and your "score" will go up in Realizeit, but the grade recorded from Realizeit to the D2L Gradebook will be the grade you have earned by the due date at 11:59PM.
- **RCII Quizzes**: The Robinson Country Intelligence Index (RCII) is designed to help you become more familiar with political and economic data and to this end, the courseware integrates the RCII and specific quizzes designed to test your familiarity with the index. You will click on the relevant RCII assessment in D2L and it will open up a quiz in Realizeit that will ask you specific questions; the answers are found by going through the RCII index (this tool will open in a separate window and you will have to finish specific steps in order to be able to answer RCII quiz questions). Make sure you read all the introductions to questions carefully as this will give you the exact instructions to follow on the index to be able to answer the questions. The very first two RCII quizzes are actually based on tutorials on how to use the index so these are simple but necessary starting points to learn how to navigate the
- Map quizzes. There will be three map quizzes that have to be completed by Friday, November 20. The three short map quizzes (10-minute limit, 2 attempts) each cover two regions of the world: A) Middle East/Former Soviet Union; B) Asia/Latin America; and C) Africa/Europe. Knowing the basic geography of the places we're covering is central to getting the most out of this course. You will have two attempts per map quiz and you should make sure that you prepare yourself for the map quizzes by utilizing the map function in the RCII and/or consult an atlas.

OPTIONAL - End of Course Essay (Bonus up to 3 points):

You will be asked to choose a topic and/or country to follow with a Google alert for international news. After following this country/topic during the term, you can write a 3-page summary paper about current events related to that country/topic as it relates to what you learned in the course this term. Details on formatting will be provided after the Midterm.

Policy on Missed Work

There is no makeup allowed for Realizeit material or the End of Course Essay, because these can be completed over several days. Makeup for the exams will only be given in cases of legitimate and documented emergencies (medical excuse, death in family, event required by your degree program). You must request to makeup exams

within 7 days of the regular exam window. For the last exam, there is no extension or makeup because I am required to submit grades to the registrar's office shortly after the exam is taken.

Last Day to drop with a grade of "W:"

Please note, the semester's midpoint is **December 4.** This is the last Day for "W". Students can withdraw from the class up to this point and receive a W for the class. However, there is a limited number of W's a student can receive over their academic career. Drops after this date will receive grades of "F." If you intend to withdraw from a course, you must do so yourself. If you are still on the roll when I have to assign grades and you haven't done any passing work, then you will fail. So, if you intend to drop, please make sure you do so in time. Also note, I have to report to the university whether students have attended class, and how regularly you attend. If you have never attended this class when I have to submit my report to the university, or you have stopped attending, it is possible that the university will drop you from the course, potentially impacting your academic record and financial assistance.

Desire-to-Learn (D2L):

Extensive use of the MSU D2L program is a required part of this course. Each student is expected to be familiar with this program as it provides a primary source of communication regarding assignments, examination materials, and general course information. While I do not post most of my PowerPoint notes to D2L, I will post a few key slides to the site just prior to each exam. These copies will serve as your study guide for the exams.

Class Behavior Policies

In order to make this a successful class, it is important that we create an environment where everyone has an opportunity to learn. This includes in-person and online classes. During class periods, no cellphones or other electronic devices are allowed; laptops may be used ONLY for the purpose of taking notes. Please put away all headphones/earbuds/Airpods as well. You should know that the university policy on disruptive behavior in class applies. Disruptive class behavior for this purpose is defined by the instructor. Such behavior includes, but is not limited to, verbal or physical threats, repeated obscenities, unreasonable interference with class discussion, making/receiving personal phone calls or pages (text messaging) during class, leaving and entering class frequently in the absence of notice to instructor of illness or other extenuating circumstances, and persisting in disruptive personal conversations with other class members. Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Refund and Repayment Policy
