# **Course/Catalog Description**

Instructional Design and Technology (IDT) is a comparatively new field dedicated to applying what is empirically understood about how humans learn and improve upon performance to the design, development, implementation, and evaluation of learning and performance support products, processes, and environments.

# **Course Objectives**

- Students can define, describe and demonstrate good instructional design principles
- Students can name, describe and demonstrate the steps of instructional design
- Students can design and apply good instructional design principles according to the needs of the learners and the learning goals
- Student can identify learner needs and abilities in terms of instructional design decision-making

#### **Instructor Drop.**

An instructor may drop a student any time during the semester for excessive absences, for consistently failing to meet class assignments, for an indifferent attitude, or for disruptive conduct. The instructor must give the student a verbal or written warning prior to dropping the student from the class. An instructor's drop of a student takes precedence over the student-initiated course drop of a later date. The instructor will assign a grade of either WF or F through the first 8 weeks of a long semester, the first 6 weeks of a 10 week summer term, or the 11th class day of a 4 or 5 week summer term consisting of

20 days. After these periods the grade will be an F. The date the instructor drop form is received in the Office of the Registrar is the official drop date.
