Course Description

This course is intended for the distance education learner. An overview of drug use in society and as a social problem is provided. Preventing and treating substance abuse will be addressed. Laws regulating drugs will be reviewed. The way various drugs work in the body, affect mood, thought, and behavior will be covered. Specific drugs addressed in detail will be stimulants, depressants, and inhalants, medications for mental disorders, alcohol, tobacco, caffeine, over-the-counter drugs, opioids, hallucinogens, marijuana, and performance-enhancing drugs.

Course Goals and Objectives

- 1. Recognize the difference between addiction, abuse, and other key concepts in substance abuse.
- 2. Understand the pharmacology, tolerance, and effects of legal and illegal substances.
- 3. Respect cultural differences in attitudes toward and use of substances.
- 4. Familiarity with substance abuse treatment and prevention.

Student Learning Outcomes

By the end of this course, students will be able to:

- 1. Describe the effects of drugs on behavior and how behaviors are influenced by psychological, social, and cultural variables.
- 2. Identify drug policies and regulations and their effects on social problems.
- 3. How drugs interact with the brain and nervous system to produce effects on behavior, thoughts, and emotions.
- 4. Identify the difference between stimulants, depressants, and inhalants, and how these compare to drugs used in treating mental disorders.
- 5. Discuss alcohol, how it affects the body and brain, and its influence on an individual's relationships with others, and its impact on society.
- 6. Identify the psychological effects of over-the-counter drugs, tobacco, and caffeine.
- 7. Describe restricted drugs, such as opioids, psychedelics, marijuana, and performance-enhancing drugs.
- 8. Utilize resources in relation to prevention and harm reduction, and discuss various policies and strategies implemented to prevent substance abuse.
- 9. Recognize the difference between addiction, abuse, and other key concepts in substance abuse.

Discussion Thread/Board Participation:

As indicated in the course schedule, the instructor will post question(s) on D2L for the class. There are *two* parts to each discussion. Everyone should post an initial response to the question(s) and should also respond to at least two peers' posts by Friday @ 11:59 pm. The discussion board is a mandatory component. Students are expected to read all discussion board instructions and to participate actively throughout the semester. Students are expected to write formally (no shorthand or text messaging abbreviations) and use APA format and referencing where appropriate. There will be general questions relating to the chapter(s), case vignettes, current events, and/or watching a video and posting your response. Thoughtful responses, constructive critique of fellow students, and meaningful participation are expected. Please keep in mind that the discussion board is a formal assignment and part of your grade.

I will review your posts and responses and give individual feedback when grading posts. I may respond in the discussion thread to a select few posts and/or responses or respond collectively to the class. This does not mean only the posts and/or responses of those to whom I respond are good, and other

posts and/or responses are not good.

NOTE: In addition to posting your discussion response in the thread, you will also upload it to the corresponding assignment dropbox. You must do this to earn full points. All student discussion posts will be checked for plagiarism and AI usage.

Discussion Rubric

Points	Responses	Expectations
4	Reply to Instructor's Questions and cited source	Discussion posts are a minimum of 2 paragraphs long and show deep understanding and original, profound thought. In addition to the text, at least one reliable (preferably peer-reviewed) source is cited and referenced in the original post.
2	Response to peer #1	Consistently responsive to classmates, including answering questions. Reply is to a chapter you have not already discussed*, is a minimum of 1 paragraph long, and develops questions related to objectives to facilitate discussion. Reply generates or stimulates group discussion and presents creative approaches to the topic.
2	Response to peer #2	Same as above.
2	Grammar Quality / Academic Integrity	Written responses are free of grammatical, spelling, or punctuation errors. The style of writing facilitates communication. Sources are properly cited and referenced using APA style. In addition to posting your discussion response in the thread, you will also upload it to the corresponding assignment dropbox. You must do this to earn full points. All student discussion posts will be checked for plagiarism and AI usage.

Quizzes

Students will complete weekly quizzes by **11:59 pm on Fridays** based on the required book chapters and unit notes as indicated in the class schedule. The quizzes are open book and notes, but there will be only 30 minutes to complete them. **Quizzes cannot be made up if missed, and a grade of zero (0) will be recorded.**

Drug Research Paper

Due Nov. 14th: Students will complete a research paper on a drug, particularly one that is discussed in the text or is problematic in this area. The paper must be double-spaced, written in the format of the American Psychological Association (APA), and be no more than 3 pages in length (excluding title and reference pages).

The paper should address, at a minimum, the following:

- What is the history of the drug?
- Why is the drug a problem for society?
- What are the problems or issues that surround the drug?
- How does the drug work? What are the adverse health effects of taking the drug?
- What are the psychological and physiological effects of the drug?
- What is being done to combat the adverse health effects associated with the drug?
- Are there any current treatments for addiction to the drug? How effective are they?

Papers must reference at least <u>one</u> other reference other than the textbook. Grading will be based on the quality of the writing, the quality of the information presented, and adherence to APA formatting. Papers will be posted for your classmates to view. This paper will be 20% of the final course grade.

Final Exam

Due Dec. 5th: The cumulative final exam will be posted in D2L. The final will be 20% of the final course grade.

Late Work

Students who fail to post required assignments on time will receive a lower grade, and those who do not complete the assignments will receive a grade of zero (0). Please review the time submission criteria on the rubrics for each assignment. If anyone fails to post an original post or reply to 3 or more assignments, they will be dropped from the course or will be given a failing grade. There are no exceptions to this rule.

Makeup Work/Tests

Missed assignments & exams cannot be made up if missed. A grade of zero (0) will be recorded.

Instructor Class Policies
