Course Description

Course focuses on the leadership challenges in organizations. Key learning outcomes in this course include current perspectives on the key elements of effective leadership, the fundamental elements and best practices in the area of organizational change, using the concepts of leadership and change to analyze organizational change situations.

Based on the theory and research in the behavioral sciences, this course covers such topics as decision making, leadership, motivation, influence tactics, and the others. Using a combination of exercises, lectures, case discussions, and group activities, this course is designed to provide students with concepts, principles, examples, and techniques that can help them better manage themselves and others in business organizations. In particular, this course teaches students how to make decisions when they do not have the time or information to engage in analytical decision-making and/or they have to rely on their intuition and experiences to resolve important decisions.

Grades will be based upon a percentage of those points earned by the student. There will be no substitutions for the above assignments. Final grades will follow the traditional demarcations as follows:

Quality Class Participation (100 points maximum): Class discussion is a critical learning vehicle. The importance and value of *your* participation cannot be stressed too highly. In order to be successful with regard to class participation, you must participate in an active and relevant way in *every* class meeting. By default, every student will receive 75 points for class participation. If you make significant contributions to class discussions, you may receive more than 75 points. However, if you miss classes, do not actively participate in class discussions or consistently make non-constructive comments, you may receive fewer than 75 points. You will lose 5 points for every class session you miss or are more than 10 minutes late. If you need to miss a class for special circumstances, you should inform me by email in advance. Please get materials and notes from a classmate.

Persistently low preparation and poor contributions will jeopardize your chances of receiving a good grade. Participation grades will be assessed according to the following criteria:

- You make valuable contributions during nearly all class sessions
- You actively discuss the topic at hand and avoid discussing matters unrelated to the course
- You consistently <u>demonstrate</u> a high level of preparation
- You frequently make valuable contributions, though not every class
- You are a constructive member during small group discussions
- You consistently <u>demonstrate</u> a high level of preparation
- You sporadically comment in class
- During group discussions you are not a productive participant (i.e., you discuss matters unrelated to the course)
- You <u>demonstrate</u> a poor level of preparation

<u>Individual/Group Exit Tickets (100 points maximum):</u> In some classes, students will have the opportunity of earning up to 10 points depending on the quality by responding to several questions about the materials under discussion. Students can answer a maximum of two questions per week but will only receive credit for the single question that scores the highest grade.

<u>Group Quizzes (100 points maximum):</u> For most classes, a group quiz will be given covering the materials under discussion. Each group can earn a maximum of 10 points on each quiz; however, the absent students cannot get any points.

Current Business Article (CBA) Presentations (100 points maximum): This is a small group project. Each group is required to present current business articles from Economist, Business Week, New York Times, Harvard Business Review, or Wall Street Journal. You can use the library databases and company websites for supplemental information. Instead of finding several articles without adequate depth about a company or a business leader, I suggest that your group find one article that provides enough depth and use other sources/articles to supplement. Each group will make three article presentations during the semester, and each presentation is worth a maximum of 50 points. Please find the due dates of these presentations on the attached schedule of classes. The best two presentations will count for your final grade.

Your specific tasks are the following: (a) identify and copy articles that relate to the concepts/frameworks in any chapter covered before the day of your CBA presentation; (b) analyze the contents of the article and prepare one-page, single-spaced written summary of your analysis; and (c) prepare slides based on your summary and make a 10-minute presentation in the class. Your group must provide me with a paper copy of items (a), (b), and (c) at least two business days before your scheduled CBA presentation.

One Personal Reflection Paper (100 points maximum): In this paper assignment, you should relate the concepts/tools covered in the course to real world experiences. First, you may briefly describe a real-world case from your experience or reported in the media. The next step is to use the concept(s) or tool(s) you have learned in this course to analyze this case. Do not use any case/example from the assigned readings or classes. Please find the due date on the attached Schedule of Classes. You may submit two reflection papers during this semester. The best one will count for your course grade.

The paper should be between 800 and 1000 words, and type-written. On the first page, you must print the following information: course number and your name ("4113 Name*"). Failure to follow these instructions may result in a deduction of points. Please try to be creative and insightful.

<u>Group Project (200 points maximum):</u> Student groups will conduct an in-depth observation and analysis of a business leader you are familiar with. Your observation should be kept in a research log

which records both the key findings you are focusing on, and other findings that may later prove to be useful. You should incorporate your observations into class discussion, and are encouraged to keep me informed on your progress. I may wish to read your log at times, and will collect the log together with your final paper. The final outcome of this observation will be a formal paper abstracted from your observation and structured using a theoretical framework you see fit. The final paper should be between 1800 words and 2400 words plus appendices, and must be type-written. Proper applications of theories, new ideas, insights as well as structure are important. The major portion of the grade will be assigned using those as criteria. Format is no small matter either. Sloppy work in terms of analysis, content, style, neatness, grammar, syntax, and spelling will be penalized and points deducted. The written paper due date has been set in the syllabus. The breakup for this portion of the grade will be as follows:

- Format and Presentation of Report (50 points)
- Research log (50 points)
- Analysis (100 points)

Students should start on this project early in the semester!

Exams (300 points maximum): There will be two exams, a midterm and a final. Both exams will be in-class and closed-book. The exams will be based not only on assigned readings, but also on materials discussed in class but not covered in the readings. If you are not satisfied with your midterm score, you may ask me to discard it; however, you must submit your request to me via email at least one week **prior** to the final exam. You may not skip the midterm or take the final exam only. There is **no** make-up for the final exam – you **must** take the final at the assigned time – no exceptions.

Late Work

The grade penalty for the late submissions is **10% off for each day** the submission is late. Work submitted more than **ten** days late will not be graded. Please check and remember the due date of each assignment on the Schedule of Classes.

Make Up Work/Tests

There is no make-up provision for any missed assignments and tests. If you feel that any material in this class has been improperly graded, you may submit a *written* appeal within one week of receiving the graded material to be regarded. In your appeal, you must both state and prove why you deserve more credit than you received.

Desire-to-Learn (D2L)

Extensive use of the MSU D2L program is a part of this course. Each student is expected to be familiar with this program as it provides a primary source of communication regarding assignments, examination materials, and general course information.
