Grading/Assessment

o Examinations (50%):

Exams may be arranged online or face-to-face. Each exam may include multiplechoice and producing visualizations using Tableau.

o Team Project (25%):

Three students work together to deliver a professional project presentation. Each group will submit a recording of the presentation (approximately 10-15 minutes) together with the completed Tableau workbook and a written report, demonstrating the questions asked and how to use data visualization to answer these questions. Detailed instructions will be provided during the semester.

o Assignments (20%):

Twelve homework will be assigned for each week after study. Ten highest will be counted, with each worth 10 points.

Points will be allocated using the following scheme. Grades will be based on the recorded points only. Personal reasons (e.g., need a specific grade to graduate, to keep financial aid, to keep straight A record, etc.) are not considered in the grade calculation.

Change of Schedule
