Past Professional Service (few noteworthy items)

1989 – 1992: MSU - original faculty member, along with Diane Spiller and lab assistant Sandra Belcher, in the MSU Department of Developmental Mathematics created by Dr. Bill Hinds, chairman of the mathematics department

1994 – 1999: The Episcopal School - involved in all aspects of brainstorming and designing new science lab for school; responsible for annual 5th/6th grade science fair; sponsored top students of school fair in the regional

science fair where my students won multiple 1st and 2nd place honors as well as Edison and other awards and even advanced to the state level

1982: Wichita State University - after participating on panel representing young female leaders in science and mathematics, was recruited by chairman of math department to join department as a full-time faculty member

1976 – 1980: Texas City ISD – chosen to serve on a two-year district-wide K-12 mathematics curriculum project committee charged with creating a comprehensive curriculum based on both entering and exiting expectations gathered from every teacher at every grade level in the district; this was an effort for our district to have its own plan in place in case the State of Texas mandated the adoption of a minimum-standards curriculum

Past Community Service

River Bend Nature Works – served as a founding board member from initial project proposal through fundraising and land acquisition to construction of the original pavilion building

Wichita Falls Museum & Art Center – served in several capacities from being a community board member to serving on the executive board, Museum Guild president, treasurer of annual Spring Fling fundraiser
