Course Description

Learners in this course will examine current theories of how people learn in online spaces that employ digital media and explore a range of online learning tools such as social networking media, Internet Communication Tools (ICT), productivity applications, and wikis. Students will develop learning experiences with these digital media.

Textbook & Instructional Materials

No textbook is required. The research will be conducted for assignments. All students must have Internet access and a computer.

Instructor Drop

An instructor may drop a student any time during the semester for excessive absences, consistently failing to meet class assignments, an indifferent attitude, or disruptive conduct. The instructor must give the student a verbal or written warning before dropping the student from the class. An instructor's drop of a student takes precedence over the student-initiated course drop at a later date. The instructor will assign a grade of either WF or F through the first 8 weeks of a long semester, the first 6 weeks of a 10-week summer term, or the 11th class day of a 4 or 5-week summer term consisting of 20 days.
