Course Description

From MSU Catalog: Class instruction in piano for students with no previous background; emphasis on the development of fundamental skills. Majors/minors only.

Course Objectives

Music majors and minors with little or no piano performance background learn fundamental piano performance skills. Students develop personal musicianship and keyboard skills necessary to pass keyboard proficiency requirements.

Students will:

- Learn keyboard technique including posture, hand position, and finger patterns
- Sight-read simple music using both hands (i.e. folk songs)
- Develop musicianship skills including ear training and rhythmic reading
- Learn major scales
- Harmonize and improvise accompaniment to simple songs
- Learn chord progressions
- Transpose simple melodies
- Perform simple pieces hands together
- Implement basic music theory into piano performance

Homework

Students receive weekly in class assignments to complete from *Alfred's Group Piano Book*, *Modern Band Piano*, and/or supplemental materials. Practicing outside of class to complete them is expected to complete assigned activities and pass designated proficiencies. Assignments are individualized for each student.

Students will be assigned skills that prepare students for future proficiencies. For example, students will practice sight reading and transposition in preparation for Piano Class 2, 3, and 4.

Academic Calendar

Desire-to-Learn (D2L)

Attendance

Piano Class 1 is a performance class. Students participate daily in individual and group activities. Activities are cumulative in organization, building on previously learned concepts. Therefore, attendance is crucial to personal development. Students may miss class twice without a final grade reduction. Each absence above the allotted two absences will reduce the final grade by one letter grade. Tardies count toward absences. Students who arrive ten minutes late will be marked absent from class. Nonparticipation in class equals one absence for each occurrence. Class participation includes all classroom activities - singing, rhythmic reading, practicing assigned material, and performing individually and as an ensemble.

The instructor may drop a student from the course for excessive absences (5 or more). A verbal or written warning will be given to a student prior to being dropped from the class.

Instructor Class Policies

Students are required to participate in all class activities and practice assigned material in preparation for each class. Practicing daily outside of class is recommended.

Students are to conduct themselves in a professional manner so that all students may learn without distraction and disruption.

College students are adults and are expected to behave accordingly. Classroom behavior that interferes with either the instructor's ability to conduct class or the ability of the other students to benefit from instruction will result in the

instructor's removing the disruptive student(s) from class, either temporarily or permanently (instructor drop). Any disruptive student asked to leave class will receive an absence.

Weather Statement

This course follows MSU Guidelines for inclement weather. Classes will not meet if campus is closed during the time of class. The class will NOT meet online if campus is closed. If assessment deadlines coincide with university closure, an extension will be stated the next class meeting.

Classroom Cleaning Protocols

Students using the Piano Lab are encouraged to clean their piano and space before and after class. Time is allotted in the 50 minutes to clean your area. Instructions will be given how to clean pianos appropriately.

Cell Phones and Other Recording Devices

The use of cell phones and other recording or electronic devices is strictly prohibited during class. The instructor may direct, from time to time, on the possible use of cell phones for legitimate class reasons. Recording the class is prohibited, unless it is part of a reasonable accommodation under ADA, or by obtaining written consent by the instructor.

Change of Schedule

A student dropping a course (but not withdrawing from the University) within the first 12 class days of a regular semester or the first four class days of a summer semester is eligible for a 100% refund of applicable tuition and fees. Dates are published in the Schedule of Classes each semester.

Privacy Statement

Federal privacy law prohibits the instructor from releasing information about students to certain parties outside of the university without the signed consent of the student. Thus, in almost all cases the professor will not discuss students' academic progress or other matters with their parents. Please do not have them call. Regardless of these important legal considerations, the professors' general policy is to communicate with the students, not their parents, even when a student has signed a consent form.

Refund and Repayment Policy

A student who withdraws or is administratively withdrawn from Midwestern State University (MSU) may be eligible to receive a refund for all or a portion of the tuition, fees, and room/board charges that were paid to MSU for the semester. However, if the student received financial aid (federal/state/institutional grants, loans, and/or scholarships), all or a portion of the refund may be returned to the financial aid programs. Smoking/Tobacco Policy

Alcohol and Drug Policy

Campus Carry

Effective August 1, 2016, the Campus Carry law (Senate Bill 11) allows those licensed individuals to carry a concealed handgun in buildings on public university campuses, except in locations the University establishes as prohibited. The new Constitutional Carry law does not change this process. Concealed carry still requires a License-to-carry permit, and openly carrying handguns is not allowed on college campuses.
