Course Description

This course will cover three major parenting theories on how to nurture children and promote normal development within a family environment. The course will also cover maltreatment of children by neglect and abuse. The effects on normal development of such maltreatment of children will be covered. This course is intended for students from a variety of disciplines and is offered only in a distance education format. Participation is a requirement of this course through internet discussions.

Course Objectives

At completion of this course students will be:

- 1. Able to discuss the Behavioral, Adlerian and Psychoanalytic approaches to parenting.
- 2. Able to define Permissive, Democratic and Autocratic parenting.
- 3. Knowledgeable about interventions into parent-child problems.
- 4. Familiar with the parenting skills associated with each theory which promote normal child development.
- 5. Able to give practical examples of how these skills can be applied in a family context.
- 6. Able to discuss the history of community services to abused and neglected children.
- 7. Able to explain the roles of the family in the raising of mentally healthy children.

- 8. Able to define the various kinds of child abuse and neglect.
- 9. Able to discuss the effects of abuse and neglect on child development.
- 10. Able to discuss the psychological and familial dynamics behind abuse and neglect.

Homework

For each week, the instructor will post question(s) on D2L for the class to respond. Unless specified otherwise, everyone should post an initial response to the question(s) and should also respond to at least one peer's post. The discussion board is a mandatory component. Students are expected to participate in the weekly discussion actively throughout the semester. Students are expected to write formally (no shorthand or text messaging abbreviations) and use APA format and referencing where appropriate. Thoughtful responses, constructive critique of fellow students, and meaningful participation are expected. Please keep in mind the discussion board is a formal assignment and part of your grade. If anyone fails to do the initial posts and fails to respond to peers' posts for any two weeks during the course will be dropped from the course.

Exams

There will be three exams (first exam, mid-term exam, and final exam). Although the points for each exam vary, each exam is assessed for 100 percent. The due dates will appear on the Course Schedule in more detail.

Late Work

If there is a legitimate reason, then late work may be accepted. But, unless there is an emergency, the instructor should be informed ahead of time.
