#### The Exam:

The exam will consist of multiple-choice questions. The exam requires the lockdown browser part of D2L and uses the Respondus Lockdown Browser and Respondus Monitor. No notes or texts may be used during the exam. Using notes, other browser windows, emailing, or texting will result in a **0**. There will be a multi-day window in which to take the exam. This course will end at the semester midpoint.

# **Technology:**

This course will be conducted in D2L. It will utilize the Respondus Lockdown Browser and Respondus Monitor for testing. In order to install these programs, you will need the following:

• A desktop computer or laptop other than a Chromebook.
