# **Assessment and Assignments:**

Student performance of knowledge and skills will be formally assessed through discussion posts and course papers.

**Discussions:** The discussions in this course give the student an opportunity to examine certain topics in the course. Discussions do not require on-campus attendance to complete. All discussions will be completed in DISCUSSIONS area in D2L.

The discussions will require some reflection before you respond. Students may offer personal experiences and/or opinions in some instances and facts in others. **The minimum word count must be 200 words** on each discussion. I do expect to see evidence that you have put some thought into these assignments. A quick way to earn a grade of zero is a low word count and also by simply rewording what someone else has written already. Therefore, you must write more than a few sentences.

Submission of all discussions must occur by particular due dates noted in the Proposed Class Schedule of Activities. Non-completion of any or all of the discussion will result in a grade of zero. This is a subjective evaluation made by the professor to determine the quality of the student's work. Simply writing something will not result in receiving full credit. Your professor is the final judge on the grade.

Please use citations in your discussion post when referring to someone else's work to be sure not to plagiarize.

# **Professional Organization Paper**

Review the following article: Burns, S.T. & Cruikshanks, D. R. (2018). *Independently licensed counselors' connection to CACREP and state professional identity requirement.* The Professional Counselor, 8(1), 29-45.

In groups of 4, students will prepare paper and on a topic regarding professional organization. Organizations include: ACA (American Counseling Association) & TCA (Texas Counseling Association); AAMFT (American Association for Marriage and Family Therapy); ACES (Association for Counselor Education and Supervision); SACES (Southern Association for Counselor Education and Supervision); CACREP (Council for Accreditation of Counseling & Related Educational Programs); NBCC (National Board for Certified Counselors); AMCD (Association for Multicultural Counseling and Development); ASGW (Association for Specialists in Group Work); CSI (Chi Sigma lota); and AHEAD (Association on Higher Education and Disability). Papers should focus on the history, purpose or mission statement, benefits, eligibility requirements, costs, applications, links, activities, and uniqueness. Please include references in your paper. This paper does not have a page requirement, as long as you include everything asked for above. (100 pts)

# **Advocacy Project**

As counselors and agents of social change, we impact the community and the profession in a variety of ways. Our voices and knowledge create change for our profession and for our clients. Two avenues to effect such change include contacting legislative bodies that create laws that effect our profession and clients and/or researching human services for our clients and ourselves. Both opportunities involve education and advocacy. *In pairs (2),* You are to write a letter or email related to legislative action. You will need to explore the ACA and state counseling association websites to become aware of the need for various legislative actions. Examples include legislative actions that provide reimbursement for counselors' services, that promote counselors' rights to practice within the limits of their training, that advocate for services for students in schools etc.

To create a thoughtful and well-informed letter/email, you will need to engage in your own research on the subject and include that information in your letter/email with correct referencing of resources (you must cite at least two professional references of research

in the body of your letter and include a references page). You may not use a standard letter that an organization has prepared. This letter/email must be in your own words. Make sure to address what you learned about the role of advocate, what you learned about yourself as an advocate, and as a result of this project what role advocacy will have in the future. The project is worth 100 points. Grading will be based on content, clarity, creativity of presentation, ownership, and enthusiasm for the project. See attached grading rubric for this assignment.

# **Professional Development Paper (KPI 1.k)**

Paper should include information on the history of counseling and how the profession came into existence. It should also include a reflection on and integration of what you have learned about yourself (as a person, student, and future counselor), about the counseling field in general, the role of advocacy in the counseling profession, and about your future plans (what you plan on doing with your degree after graduation). It should also include what you think the "best" and "worst" parts of being a counselor/therapist will be. Paper must be written in APA format (refer to APA manual). Length of paper should be at least 3-6 pages and must include at least three references. You may use your book as one reference.
