# • Participation (15%)

Students must participate in class activities, projects, and discussions. Evidence of class participation includes: attendance, being on time, participating in class discussions, and submitting assignments on time. Each unexcused absence (see attendance) will be a 10 point deduction.

# • Pathology Project (15%)

The purpose of this project is to reinforce the student's understanding of a pathologic condition and the medical imaging procedures used for diagnosing such pathology.

This project will be presented in class as a group presentation.

Papers and other assignments may be submitted to an external agency for verification of originality and authenticity.

Whenever a student is unsure of whether a particular situation will be interpreted as academic dishonesty, the student should ask the instructor for clarification. If students are guilty of academic dishonesty, a grade of zero (0) may be given for the quiz, assignment, etc. Cases may also be referred to the Dean of Students for possible dismissal from the university.
