# Email/Course Announcement Requirements

#### Discussion Boards

Discussion content and questions will be posted on certain weeks throughout the semester. You can see the weeks that will include a discussion assignment on the course schedule within this syllabus. During the weeks that have two discussions, an initial post must be submitted for each discussion by Wednesday at 11:59 PM CST. Additionally, two substantial responses for each discussion must be made by Sunday at 11:59 PM CST. Each discussion has a max point value of six points. Two points will be given for your initial post, and two points will be given for each of your response posts. All discussion boards are expected to raise thoughtful questions, incorporate content from readings, build on the ideas of others, expand the class' perspective, and appropriately challenge perspectives and assumptions. Students must support their posts in proper APA formatting, including in-text citations and complete reference entires. Initial posts should be at least 200 words in content. Response posts should be at least 100 words in content. Discussion Boards count for 18% of your final grade.

# Self-Care Plan Assignment

Self-care, aka personal wellness, is vital for employees and managers. Self-care reduces stress and burnout while encouraging employee retention. For this

assignment, you will create a personalized self-care plan. The goal is to determine the activities that will enable you to take time for yourself; therefore, there are no incorrect responses. Please review the videos within the module and this brochure on <a href="building a self-care plan">building a self-care plan</a>. It explains the essential aspects of self-care. The information will be helpful when you are creating your plan. You may use the format found within **Step Two (on page three of the brochure)** or create a document (WORD, Excel, or any format you choose). **The plan can be as detailed as you like and must include at least two activities for the following seven self-care categories: Physical, Emotional, Spiritual, Professional, Social, Financial, and Psychological.** Additionally, please list three positive coping strategies that you can employ when faced with challenging situations. A grading rubric for the Self-Care Plan can be found in the Learning Tools within the D2L course. Submit your completed plan to the Self-Care Dropbox by Sunday, October 9th. The Self-care Plan assignment is worth 5% of your final grade.

Management Problem and Proposed Solution Paper There will be one Management written paper in this course. The purpose is to identify a management problem you have either encountered in your workplace or covered within the course materials and suggest a possible solution for the problem. This assignment must be submitted as a *Word document (no PDFs)* with at least two to three full pages in length (excluding title and reference pages). Students can sign up for free access to the Office 365 web edition at the Microsoft Office 365 Education site. Email the MSU Helpdesk or call 940-397-4680 should you have any issues. The Paper must be written according to 7<sup>th</sup> Edition APA guidelines, including in-text citations, page numbers, utilizing a font no greater than 12 with 1-inch margins, and double-spaced. While this paper must follow APA guidelines, an abstract is not required for this assignment. Within your paper, you must reference at least three recent (published within the last five years) scholarly, peer-reviewed journal articles supporting your proposed solution. An excellent APA resource can be found on the Purdue OWL website. I do expect well-written papers of the collegiate level. A grading rubric for the Management Paper can be found in the D2L course Learning Tools. The Management Paper is due October 2nd and is worth 35% of your final grade.

#### Quizzes

There will be five quizzes, which will cover several chapters within the text and additional readings that may be assigned. Students are expected to analyze and apply their education and knowledge during these quizzes. Quizzes are located

under assessments. You may use learning resources to help you with the quizzes; however, the quizzes are timed and may only be taken once. Quizzes/Exams account for 40% of your final grade.

## Late Work

D2L is designed so that students are locked out of the system after the deadline has passed. Please make a note of all deadlines and adhere to them. All assignments must be completed by 11:59 PM CST on the due date. Any coursework not completed and submitted on time will be graded as a zero. #### Attendance

This is an online course and students are required to regularly login and check for any announcements posted. Students are expected to attend all meetings of the classes in which they are enrolled. Although in general students are graded on intellectual effort and performance rather than attendance, absences may lower the student's grade where class attendance and class participation are deemed essential by the faculty member. In those classes where attendance is considered as part of the grade, the instructor should so inform students of the specifics in writing at the beginning of the semester in a syllabus or separate attendance policy statement. # Change of Schedule
