Catalog Description: SPCH 2423 Interpersonal Communication is the application of communication theory to interpersonal relationship development, maintenance, and termination in relationship contexts including friendships, romantic partners, families, and relationships with co-workers and supervisors.

Course Overview: Communication is the single most important tool we have to make sense of our world. Hence, the way in which we understand our own experiences and others is through the communication process. *SPCH 2423* will enable you to improve your theoretical knowledge of the interpersonal communication process while providing you with practical application skills to use both personally and professionally.

- (5) Demonstrate understanding of the relevance of <u>cross-cultural</u>, <u>co-cultural</u>, <u>gender and age influences</u> on human communication.
- (6) Demonstrate ability to identify, evaluate, and apply <u>conflict styles and conflict management techniques</u> in dyads and/or groups.
- (7) Identify types of and barriers to effective listening in interpersonal contexts.

Class Participation

Since this is a full online course, you are expected to actively participate and keep up with the assignments. This includes videos, readings, discussions, etc. For discussions, students should write one original comment as well as reply to at least one other posting. All speeches will be recorded (faces must be seen) and submitted with a link. There may be online Zoom sessions, but those will be communicated well ahead of time. While they are not mandatory, attendance is highly encouraged.

Privacy

The new Constitutional Carry law does not change this process. Concealed carry still requires a License to Carry permit, and openly carrying handguns is not allowed on college campuses.
