Course Description

This course covers Quantitative Chemical Analysis, including Statistical Analysis and Error Treatment, Basic Calculations in Stoichiometry, Acid-Base Equilibrium, Precipitation Equilibrium, Complexation Equilibrium and Redox Equilibrium, UV-visible spectrometry and Gas and Liquid Chromatography.
