Course Description

A course designed to increase the variety and depth of the student's exposure to music and to enhance understanding and enjoyment of music as an art.

- 4. To investigate unique characteristics and differences of each style period and of major composers

Quizzes

There are quizzes for each lesson that we will cover in this class. Quizzes match up with the chapter content and equal one quiz for each day of classes. All the quizzes are open from the first day of class and have due dates for each. The quizzes will close on that date and will no longer be available to take. All quizzes are due by 11:59 pm the day before the next lesson.

*Keep in mind that the practice questions, found under the "Test Yourself" section in the reading are very similar to the questions on the quizzes and make for good practice!

Exams:

There are two major exams for this course, a Midterm and a Final Exam. The midterm covers lessons 1-20; the final covers lessons 21-40. Each exam is 80 questions and has a two-hour time limit.

Concert Reviews:

There are three concert reviews to be completed throughout the semester. Each written review must be a minimum of 500 words.

- You will attend or listen online to THREE live concerts or recitals this semester.
- You are required to listen to or attend the entire concert.
- For each of the concerts, you will write a 500-word concert report, and submit proof of attendance.
- See the course schedule for the concert attendance and concert report deadlines.
- The concert report should describe the type, time, and location of the concert and discuss the musical aspects of each work performed. Included in the report should be a discussion of the elements of music that you heard in the specific works. If the concert has a large number of works, you may choose certain works to write about.
- Attach a copy of the concert program to your concert review, if one is available.
- Attach a photo of yourself at the concert you are attending.

Written Instructions:

- Your concert report must be a minimum of 500 words
- Double-spaced
- Your full name, concert review number, and date
- Title of concert and date as heading
- Attach a copy of the program, if one is available
- Attach a photo of yourself at the concert you are reviewing

General points to consider:

- The concert as a whole
- Name and type of performance, place, date and time, and the type of music you hear
- Your general reaction to the performance
- Musical styles performed
- Musical genres and forms
- Emotions, images, and ideas

- Memorable features
- Compare with other works
- Use sources to aid in identifying information
- Use any standard citation method

Performance aspects to consider:

- Emotional projection
- Dynamics
- Tempos
- Melodies
- Vocal Range
- Instruments
- The conductor

Concert Etiquette: Live performances at Midwestern State University and other "classical" venues typically take place in formal concert halls with campus and community members, business sponsors, distinguished visitors, and dignitaries in attendance. Every concert is recorded and the recordings are used for students' grades, graduate school and professional auditions, concert/convention performance auditions, marketing, and archival purposes. These recordings are made with high-quality, sensitive microphones. Due to the nature of these concerts, when in attendance, absolutely NO talking, and NO USE of cell phones, laptops, or other electronic devices are permissible. Late arrivals should wait to hear applause before entering the concert hall and the student should take the first available seat upon entering (a student cannot write a concert report for a recital in which he or she arrived late). If a student must exit the performance, he or she must do so between works (during applause or intermission) and never during a performance. No food or drink in concert halls. Students may be asked to leave should there be a disruption. Students disrupting performances will be at risk of dismissal from the concert, lowered overall grades, or failure of the course.
