Course Description

This course reviews the etiology, pathology, pathophysiology, clinical features, and treatments for common pulmonary diseases in the adult and pediatric populations.

- Demonstrate ability to apply appropriate therapeutic interventions for each identified pathophysiological process.

Chapter Review and Quizzes

This course is a review of various respiratory pathologies in the adult and pediatric populations. Skim the chapters included in the course content section and select 12 chapters of interest. The student will read the chapter selected along with the PowerPoint presentations and take the associated chapter quiz. This course is self-paced but recommended that the student complete approximately two chapters per week. *All students will complete Chapters 10, 11, and 12 by June 6th. Students must also submit their selection of 12 additional chapters via the D2L Chapter Survey by June 6th. Failure to submit the survey by June 6th will result in the Instructor randomly assigning the remaining 12 quizzes. Requested quizzes will be made available under the assessment icon for each student. Please note that the selected quizzes must be manually opened and done after the submission deadline.*

Patient Case Report

- Select a topic relating to a disease/condition covered in the text. You have the option of utilizing an actual case study (either located on the internet or in your professional practice).
- First, provide an overview of the disease.
- Next, present the patient's case in any format you desire (SOAP note format or free text). Include all clinical manifestations relevant to the case study.
- Finally, discuss the patient's treatment while highlighting any potential or recommended changes. Focus on patient assessment, therapeutic interventions, care plan, and management. Discuss whether or not the patient was managed according to published standards (evidence-based practice).

- Within the report, cite at least three current (published within the last five years) peer-reviewed research articles that focus on the patient's disease/condition. These sources should correlate with your subject content. Please do not hesitate to utilize additional sources as well.
- The report must be written according to 7th Edition APA guidelines, including in-text citations, page numbers, utilizing a font no greater than 12 with 1-inch margins and double-spaced. While this paper must follow APA guidelines, an abstract is not required for this assignment. An excellent APA resource can be found on the <u>Purdue OWL website</u>.
- The amount of student-written material (excluding the Title Page and References page) must total at least five pages. You will be graded on the overall coverage of the subject and readability of the report. Points will be deducted for spelling and grammar.
- Reports should be submitted to the assignment Case Report dropbox by July 25th.

Late Work

D2L is designed so that students are locked out of the system after the deadline has passed. Please make a note of all deadlines and adhere to them. All assignments must be completed by 11:59 PM CST on the due date. Any coursework not completed and submitted on time will be graded as a zero.
