Course Description

This online course reviews the etiology, pathology, pathophysiology, clinical features, and treatments for common pulmonary diseases in the adult and pediatric populations.

- Identify etiology, pathology, pathophysiology, and clinical features associated with standard respiratory disease processes.
- Demonstrate ability to apply appropriate therapeutic interventions for each identified pathophysiological process.

#### Chapter Review and Quizzes

This course is a review of 15 various respiratory pathologies in the adult and pediatric populations. The Instructor will choose 11 of the 15 quizzes. Skim the chapters of the textbook and included in the course content section then select 4 additional chapters of interest. The student will read the chapters selected along with the PowerPoint presentations and take the associated chapter quiz. This course is self-paced but recommended that the student complete approximately two chapters per week. *All students will complete Chapters 10, 11, and 12 by **June 18<sup>th</sup>**. Students must also submit their selection of 4 additional chapters via the D2L Chapter Survey by **June 11<sup>th</sup>**. Failure to submit the survey by the deadline will result in the Instructor randomly assigning the remaining 4 quizzes. Requested quizzes will be made available under the assessment icon for each*

*student. Please note that the 4 selected quizzes must be manually opened and done after the submission deadline.*

### Patient Case Report

This assignment is **NEITHER** a research paper **NOR** a report on a disease process.

- Select a topic relating to a disease/condition covered in the text. You have the option of utilizing an actual case study (either located on the internet or in your professional practice).
- First, provide an overview of the disease.
- Next, present the patient's case in any format you desire (SOAP/SOAPIER note format or free text). Include all clinical manifestations relevant to the case study.
- Finally, discuss the patient's treatment while highlighting any potential or recommended changes. Focus on the patient assessment, therapeutic interventions, care plan, and management. Discuss whether or not the patient was managed according to published standards (evidence-based practice).
- **Within the report, cite at least three current (published within the last five years) peer-reviewed research articles that focus on the patient's disease/condition.**
- The report must be written according to 7<sup>th</sup> Edition APA guidelines, including in-text citations, page numbers, utilizing a font no greater than 12 with 1-inch margins and double-spaced. While this paper must follow APA guidelines, an abstract is not required for this assignment. An excellent APA resource can be found on the [Purdue OWL website](#).
- The amount of student-written material (excluding the Title Page and References page) must total at least five pages. You will be graded on the overall coverage of the subject and readability of the report. Points will be deducted for spelling and grammar.
- This assignment must be submitted as a *Word document (no PDFs)*. Students can sign up for free access to the Office 365 web edition at the [Microsoft Office 365 Education](#) site. Email the [MSU Helpdesk](#) or call 940-397-4680 should you have any issues.
- **Reports should be submitted to the assignment Case Report Dropbox by *July 23rd at 11:59 PM CST.***
