### Course Description

General survey of American History from 1865 to the present. Required of all baccalaureate students.

### Course Objectives/Learning Outcomes/Course Competencies

During this course, students will learn how to:

1. identify key events, peoples, individuals, terms, periods, and chronology of the history of the United States; distinguish between historical fact and historical interpretation; and connect historical events in chronological chain(s) of cause and effect

- a. You will learn what happened and how different historians interpret those events.
2. develop critical thinking skills by discussing the living nature of history, using historical evidence to critique competing interpretations of the same historical events, explaining the nature of historical controversies
  - a. We will go into detail about why historic controversies exist and how to evaluate their merits against each other
3. synthesize diverse historical information and evidence related to broad themes of U.S. history and present this information in coherent, well-articulated, and well-substantiated analytical discussions and other written assignments
  - a. I will ask you to think critically about people, events, and ideas both in class as well as through assignments
4. develop the ability to connect choices, actions, and consequences to ethical decision making by examining the motivations and actions of key figures in U.S. history
  - a. By the end of the class you should be able to start doing history yourself
5. learn how to sift through a large amount of information and categorize in order to determine its importance and aid in its retention
  - a. You will learn a way to take notes.

#### Homework

Homework for this class is mostly limited to readings from the assigned textbook and should be completed on the day listed.

#### Projects Required

There is one project for this course that is split into four separate essays where I ask you to analyze a historical figure of your choice and both their positive and negative effects on history. I will hand out information about each essay when we get closer to the due date.

#### Mid-Term Exam

Mid-Term exams will have two components: An identification section where you are asked to identify key terms discussed in class and an essay section where you are right about the broader theme of the class. The exam should not take more than fifty minutes to complete and is worth 100 points or 10 percent of your grade.

#### Final Exam

The Final Exam will be exactly like the mid-term exam in format with two sections: an identification section and an essay section. The essay will be cumulative, and I will ask you a question about the larger scope of the class. The exam should not take you more than fifty minutes and is worth 100 points or 10 percent of your grade.

### Extra Credit

I do not grant individual extra credit, but may offer extra credit for attending a guest lecture or something of that nature (but do not have anything planned at this time)

### Late Work

Late work will not be accepted unless student arranges an extension before the due date, or extenuating circumstances keep the student from asking for an extension.
