CMPS 5243 – Algorithm Analysis Spring 2021

Course Objective: This course is a study of the design and analysis of algorithms for the processing of numeric and nonnumeric data.

Course Prerequisite: CMPS 3013 and MATH 1634.

Text: Introduction to Algorithms, 3th ed. By Cormen, Leiserson, Rivest, & Stein

Missed Programs: This class is considered a programming course. **All projects must be attempted.** If a student fails to turn in any project, he/she will receive an F in the course.

Late Policy: Projects will be accepted late up to one week after the due date with a penalty of 5 points per day. The D2L submission date will be the official date for calculating a late penalty. *Late projects will not be accepted for a grade after one week from the due date.*

Quizzes and other assignments <u>will not be accepted after the due date</u>. All assignments are due at the *beginning* of class on the due date. If you are late to class, your assignment will be counted late. One quiz/assignment will be dropped.

Academic Honesty: The Department of Computer Science had adopted the following policy related to cheating (academic misconduct). The policy will be applied to all instances of cheating on assignments and exams as determined by the instructor of the course. (See below for link to MSU definitions.)

- 1st instance of cheating in a course: The student will be assigned a non-replaceable grade of zero for the assignment, project or exam. In addition, the student will receive a one letter grade reduction in course.
