## **Course Description**

This course provides an introduction to the social work profession, its history, values, ethics, concepts, skills and activities, and the contemporary context of social work practice. It will investigate the relationship between social welfare and American society from the historical development and the contemporary perspective of the social work profession. The role of social work in meeting common human needs are examined in various agency settings with the diverse client groups served by the social work profession. This course is designed to assist students in clarification and selection of social work as a major. It is required of all applicants to the social work program but it is not limited to them.

## **Course Goals and Objectives**

• Students will become familiar with the social work mission, practice settings, and client populations

Skills learned will be:

• Practice personal reflection and self-correction to assure continual professional development

Values learned will be:

- Identify with the social work profession and conduct themselves accordingly
- Learn to apply social work ethical principles to guide professional practice
- Attend to professional roles and boundaries
- Recognize and manage personal values in a way that allows professional values to guide practice
- Make ethical decisions by applying the NASW code of ethics

## **College Policies**

## **Campus Carry Rules/Policies**

Senate Bill 11 passed by the 84th Texas Legislature allows licensed handgun holders to carry concealed handguns on campus, effective August 1, 2016. ## Smoking/Tobacco Policy

Midwestern State University seeks to provide a safe, healthy, pleasant environment for its faculty, staff, and students. To this end, the use of tobacco products, including smoke and smokeless tobacco, and the advertising, sale, free distribution, and discarding of tobacco products shall be prohibited in all indoor and outdoor facilities and in all university vehicles. The policy extends to faculty, staff, students, vendors, guests, and visitors.

## **Alcohol and Drug Policy**

## **Professional Expectations of Student Behavior**

Midwestern State University Department of Social Work is mandated by the Council on Social Work Education (CSWE) to foster and evaluate professional behavioral development for all students in social work courses. The Department of Social Work also bears a responsibility to the community at large to produce fully trained professional social workers who consciously exhibit the knowledge, values, and skills of the profession of social work. The values of the profession are codified in the <u>NASW Code of Ethics</u>. Given this context, all students taking classes in the social work program will be expected to exhibit the following ethical standards of behavior.

- 1. **Accountability**: Complete reading assignments, participate in class discussions, and submit assignments on time.
  - a. Participate in group activities and assignments at a comparable level to peers.
  - b. Complete work in a timely fashion and according to directions provided.
- 2. **Respect:** Treat all your peers, your instructors and all those you come in contact with, with dignity and respect at all times.
  - a. Give feedback to peers in a constructive manner.
  - b. Approach conflict with peers or instructors in a cooperative manner.
  - c. Use positive and nonjudgmental language.
- 3. **Confidentiality**: Treat any personal information that you hear about a peer or an instructor as strictly confidential.
  - a. Maintain any information shared in class, dyads, or smaller groups within that unit.
  - b. Use judgment in self-disclosing information of a very personal nature in the class. (Class time should not be used as therapy or treatment. If students feel the need to talk about issues they are struggling with, they may consult with their instructor to receive a referral for counseling.)
  - c. Never use names of clients or disclose other identifying information in the classroom.
- 4. **Competence**: Apply yourself to all your academic pursuits with seriousness and conscientiousness, meeting all deadlines as given by your instructors. Constantly strive to improve your abilities.
  - a. Seek out appropriate support when having difficulties to ensure success in completing course requirements.
  - b. Take responsibility for the quality of completed tests and assignments.
  - c. Strive to work toward greater awareness of personal issues that may impede your effectiveness with clients.
- 5. **Integrity**: Practice honesty with yourself, your peers, and your instructors. Constantly strive to improve your abilities.
  - a. Academic: Commit yourself to learning the rules of citing others work properly.

- b. Do your own work and take credit only for your own work.
- c. Acknowledge areas where improvement is needed.
- d. Accept and benefit from constructive feedback

Submission of Papers: Students will submit their written assignments on paper and electronically. Electronic copies will be subject to plagiarism analysis and will be kept in an electronic file for future reference. A student may not submit the same paper, or essentially the same, paper, project, assignment, or finished project to an instructor, which has been submitted to another instructor, unless specifically authorized by both instructors to do so.

- 6. **Diversity**: Strive to become more open to people, ideas, and creeds that you are not familiar with. Embrace diversity.
  - a. Maintain speech free of racism, sexism, ableism, heterosexism, or stereotyping.
  - b. Exhibit a willingness to serve diverse groups of persons.
  - c. Demonstrate an understanding of how values and culture interact.
- 7. **Communication**: Strive to improve both verbal and written communication skills as these skills are used heavily in interactions with clients and peers and also with creating client records.
  - a. Demonstrate assertive communication with peers and instructors.
  - b. Practice positive, constructive, respectful, and professional communication skills with peers and instructor: (body language, empathy, listening)
- 8. **Social Justice**: Strive to deepen your commitment to social justice for all populations at risk.
  - a. Demonstrate an understanding of how institutional and personal oppression impede the experience of social justice for individuals and groups.
  - b. Strive to learn about methods of empowering populations and enhancing social justice at micro, mezzo, and macro levels.

#### **Consequences of Unacceptable Behavior**

The Department of Social Work may terminate a student's participation in the program on the basis of professional non-suitability if the Department's faculty members determine that a student's behavior has constituted a significant violation or pattern of violations of the NASW Code of Ethics, the MSU of Social Work Student Manual, or the MSU Academic Policies and Regulations. Examples of violations that may lead to termination include (but are not limited to) the following:

1. Failure to meet or maintain academic grade point requirements as established by the University and the Social Work program.

2. Academic cheating, lying, or plagiarism (turnitin.com will be used to check the originality of the text).

3. Behavior judged to be in violation of the NASW Code of Ethics.

4. Failure to meet generally accepted standards of professional conduct, personal integrity, or emotional stability requisite for professional practice.5. Inappropriate or disruptive behavior toward colleagues, faculty, or staff (at the department or in the field placement).

6. Consistent failure to demonstrate effective interpersonal skills necessary for forming professional relationships (for example, unable to demonstrate nonjudgmental attitude or unable to allow client self-determination).

7. Documented evidence of criminal activity occurring during the course of study.

## Desire-to-Learn (D2L)

Extensive use of the MSU D2L program is a part of this course. Each student is expected to be familiar with this program as it provides a primary source of communication regarding assignments, examination materials, and general course information. ## Agency Report Hours/Paper/Presentation

<u>Agency Volunteer Hours-20 hours required</u> - <u>due November 18th</u> Each student will volunteer at a social service agency. A list of possible sites is included with this syllabus.

- a. You are to volunteer for <u>20 hours</u>.
- b. These 20 hours are to be completed no later than the due date on the course outline.
- c. You must select and confirm your agency by **<u>September 9th</u>** and complete the form in D2L.
- d. Your supervisor must complete and sign the <u>Agency Volunteer Hours</u> <u>Verification form</u> when you have completed your 20 hours. This will be turned in with your paper.
- e. You will be dropped one letter grade for not completing the agency report assignment and you will be dropped one letter grade if you do not complete the volunteer hours assignment.

## Agency report assignment- Due November 18th

The paper must be typed (double space). Please write each question and then follow the question with the answer. Question #9 should be very thorough and require some thought. Paper must be submitted in D2L and posted for classmates to read/comment in D2L. **Your paper will not be accepted without verification that you completed the 20 hour volunteer assignment**. Incomplete grades will not be given for late assignments unless there is documented proof of a real emergency, therefore, get your hours completed and your paper finished by the due date.

Answer the following in at least two pages:

- 1. Name of agency and location
- 2. Mission/Goals of the agency
- 3. Describe the agency's purpose, including what population it serves
- 4. Types of services they provide to the community
- 5. Eligibility of its clients
- 6. Sources of funding
- 7. Where do referrals come from?
- 8. How does (or could) the agency use research?
- 9. Please take time to reflect on the information you gathered from your and speak to your own career goals.
  - -Is this something you would like to do as a social worker?
  - -What about the position interests you?
  - -What about the position concerns you?

## Agency Presentation - Begin November 16th

You will present the information from your agency paper to the class. The purpose is to educate your classmates on a variety of social service agencies. You may choose to utilize any type of media (video, powerpoint/slides, <u>tiktok</u>, <u>padlet</u>, <u>storyboard</u>, <u>bitmoji scenes</u>, <u>kahoot</u>, etc.). Get creative!! The presentations will be conducted during the last two weeks of the semester.

## Final Exam

**Due December 3rd:** There will be a cumulative, open book final exam at the end of the semester that will be completed in D2L. You will have 90 minutes to complete the exam. If the exam is missed due to an unexcused absence, the student will receive a score of zero (0).
