## **Course Description**

A survey of English literature of the Romantic, Victorian, and Modern periods. Emphasis is on the works of principal authors as they reflect literary and historical backgrounds.

By the end of the course, students will be able to:

- Analyze texts through close reading and attention to detail
- Integrate various works through discussions of common themes, especially those themes that reach across cultural boundaries
- Engage with themes and ideas through writing, including a major research project and class discussion
- Do literary research using standard reference works, databases, and electronic sources
- Construct a logical argument in support of a thesis for a research paper, an argument that will show awareness of cultural differences while remaining free of cultural bias
- Write a unified and coherent research paper that demonstrates proficiency in Standard English and that follows the Modern Language Association's guidelines for form and style

## Grading

This class will not use the plus/minus grading system. In this class, the following numerical equivalents for final grades are used: A = 100-90%; B = 89-80%; C = 79-70%; D = 69-60%; F = 59-0%. Please review the significance of each letter grade (taken from the MSU's Undergraduate Catalogue, p. 73). Essays that meet the basic requirements earn a C, not an A or B. If you wish to earn As and Bs, you will have to work harder to produce better than satisfactory, or average, writing.

## **Midterm Grades**

In order to help students keep track of their progress toward course objectives, I will provide a Midterm Progress Report through each student's WebWorld account. I will submit a grade for all students, not just those in danger of failing the course. Midterm grades will not be reported on the students' transcript; nor will they be calculated in the cumulative GPA. They simply give you an idea of where you

stand at the midpoint of the semester. Students earning below a C at the midway point should make an appointment with me and consider taking advantage of the TASP services (see below).

### Writing Proficiency Requirement

All students seeking a Bachelor's degree from Midwestern State University must satisfy a writing proficiency requirement once they've 1) passed the 6 hours of Communication Core and 2) earned 60 hours.
